WARREN 1.600 ACRES

Lying in Section 27, Town 6, Range 8, Stokes Township, Village of Lakeview, Logan County, Ohio.

Being the Frederick C. Warren 2.230 acre tract, and all of Lot 13 and part of Lot 14, Lakeview original plat (Plat Cabinet A, Slide 121) as deeded and described in Offical Record 191, Page 896, Tracts I, II, III, IV and being more particularly described as follows:

Beginning at a 5/8 inch iron rod found at the southeast corner of Lot 17 of the Village of Lakeview.

THENCE, with the southerly line of the James E. Duff 1.75 acre tract (Vol. 395, Pg. 359), N 59°-54'-17" E, a distance of 145.20 feet to a 5/8 inch iron rod found.

THENCE, with the west right-of-way of State Route 33 (160 feet wide), with a curve to the left having a central angle of 4°-53'50", a radius of 4663.66 feet, an arc length of 398.61 feet, and a chord bearing S 30°-37'-56"-E, a distance of 398.49 feet to a 5/8 inch iron rod set.

THENCE, with the northerly line of The Village of Lakeview 0.22 acre tract (Vol. 404, Pg. 752), S 60°-20'-12" W, a distance of 146.00 feet to a 5/8 inch iron rod set.

THENCE, with the easterly lines of Lot 11 and Lot 12, N 30°-30'-18" W, a distance of 132.30 feet to a 5/8 inch iron rod found.

THENCE, with northerly line of the said Lot 12, S 60°-16'-58" W, a distance of 165.11 feet to a 5/8 inch iron rod set on the easterly right-of-way of Main Street (60 feet wide).

THENCE, with the easterly right-of-way of Main Street, N 30°-31'50" W, a distance of 66.00 feet to a 5/8 inch iron rod set.

THENCE, with the lines of Bret N. Mathewson part of Lot 14 (Vol. 397, Pg. 841) the following two courses:

N 60°-14'-03" E, a distance of 135.00 feet to a 3/4 inch iron pipe found.

N 30°-27'-16" W, a distance of 66.00 feet to a 5/8 inch iron rod set.

THENCE, with the southerly line of Lot 15, N 60°-14'-02" E, a distance of 30.00 feet to a 3/4 inch iron pipe found.

THENCE, with the east line of the said Lot 15 and Lot 16, N 30°-30'-52" W, a distance of 132.95 feet to the point of beginning.


Containing 1.600 acres with 0.046 acre in Lot 14 and 0.250 acre in Lot 13.




