WATT 0.104 ACRE

Lying in Section 27, Town 6, Range 8, Village of Lakeview, Stokes Township, Logan County, Ohio.

Being all of the Eddie Watt Lots 534 and 535 of Nichelson's Fifth Addition (Plat Cabinet A, Slide 229) as deeded in Official Record 593, Page 591 and Official Record 571, Page 145 of the Logan County Records of Deeds and being more particularly described as follows:

Beginning on a 5/8 inch iron rod found at the northeast corner of Lot 534 on the intersection of the south right-of-way of Grove Avenue and the west right-of-way of State Street.

THENCE, with the west right-of-way of State Street (40 feet wide), S 00°-23'-29"W, a distance of 56.45 feet to a ¾ inch iron pipe found at the northeast corner of Lot 533.

THENCE, with the north lines of Lots 533 and 532, S 89°-59'-38"W, a distance of 80.06 feet to a 5/8 inch iron rod set at the southeast corner of Lot 536.

THENCE, with the east line of Lot 536, N 00°-19'-25"E, a distance of 56.45 feet to a 5/8 inch iron rod set on the south right-of-way of Grove Avenue.

THENCE, with the south right-of-way of Grove Avenue (40 feet wide), N 90°-00'-00"E, a distance of 80.12 feet to the point of beginning.

Containing 0.104 acre.

The basis for bearings is the south right-of-way of Grove Avenue, being N 90°-00'-00"E, and all other bearings are from angles and distances measured in a field survey by Lee Surveying and Mapping Co., Inc. on September 28, 2009.


