


The following described tract of land situated in Monroe Township, Logan County, Ohio and being in Virginia Military Survey 3224, bounded and described as follows:-



Beginning for reference at a Mag Nail set at the intersection of the centerlines of Township Road 164 (variable width right-of-way) and Township Road 178 (60' right-of-way);

thence with the centerline of Township Road 178, S-16°27′03″-E, 13.56′(feet) to a Mag Nail set at the **PRINCIPLE PLACE OF BEGINNING** for the tract hereinafter described;

thence N-73°54'21"-E, 302.38'(feet) to a Mag Nail set within the right-of-way of Township Road 164;

thence S-11°43'40"-E, 624.85'(feet) to an iron bar set, passing for reference an iron bar set on the right-of-way line of Township Road 164 at 23.02'(feet);

thence S-67°20′30″-W, 287.79′(feet) to an iron bar set on the centerline of Township Road 178, passing for reference an iron bar set on the right-of-way line of Township Road 178 at 222.23′(feet);

thence with the centerline of Township Road 178, N-46°13′41″-E, 39.59′(feet) to an iron bar set at a centerline P.I. of Township Road 178;

thence continuing with the centerline of Township Road 178, N-16°27′03″-W, 637.56′(feet) to the place of beginning.
