LEGAL DESCRIPTION Ingress-Egress Easement U. S. Route 68 West Liberty, Ohio

Situated in the Township of Liberty County of Logan and State of Ohio and known as being part of Section 35, Township 5, Range 13, further known as being part of that parcel of land conveyed to Gary W. Richardson and Darla K. Richardson by deed dated March 2, 1999 and recorded in Official Record Volume 402, Page 528 of Logan County Records, said premises being more particularly bounded and described as follows:

Commencing for reference at the intersection of the northerly line of the aforementioned Richardson lands and the centerline of U. S. Route 68, said point being Centerline Station 102+90 as shown on the Logan County Engineer's Plan M-40;

Thence North 84°-45'-14" West along the northerly line of said Richardson lands, a distance of 30.00 feet to its intersection with the westerly line of U.S. Route 68 and the TRUE PLACE OF BEGINNING of the premises herein described;

Course No. 1: thence South 04°-47'-00" West along the westerly line of U. S. Route 68. a distance of 25.00 feet to a point;

Course No. 2: thence North 84°-45'-14" West, a distance of 281.21 feet to a point;

Course No. 3: thence South 61°-24'-16" West, a distance of 28.53 feet to a point;

Course No. 4: thence South 10°-01'-00" West, a distance of 90.10 feet to a point on a southerly line of the aforementioned Richardson lands;

Course No. 5: thence South 88°-25'-00" West along a southerly line of said Richardson lands, a distance of 15.31 feet to an internal corner thereof;

Course No. 6: thence South 04°-47'-00" West an easterly line of said Richardson lands, a distance of 87.13 feet to a southeasterly corner thereof;

Course No. 7: thence South 88°-49'-47" West along a southerly line of said Richardson lands, a distance of 48.02 feet to a point;

Course No. 8: thence North 50°-27'-58" East, a distance of 44.94 feet to a point;

Course No. 9: thence North 10°-01'-00" East, a distance of 167.09 feet to a point;


Course No. 10: thence North 61°-24'-16" East, a distance of 48.16 feet to a point on the aforementioned northerly line of said Richardson lands;



Beginning at a 5/8" iron rod set on the southwest corner of the said 3.97 acre tract.

THENCE, with the west line of the said 3.97 acre tract, the same being the east line of the Oelker land (Volume 407, Page 490), N 3°-58'-19" E, a distance of 247.35 feet to a 5/8" iron rod (set).




