Being situate in the State of Ohio, County of Logan, Township of Liberty and being a part of the Northeast quarter of Section 25, Town 4-South, Range 14-East, and being more particularly described as follows:

Beginning for reference at a railroad spike found at the intersection of the quarter section line of said Section 25 and the centerline of Township Road 199 (40' right-of-way), also being at the Northwest corner of an 11.98 acre tract conveyed to Mark A. Jones by Deed recorded in Official Record 11, Page 650, Tract One, of the Logan County Records;

thence with the centerline of Township Road 199, S-86°42'00"-E, 400.64' (feet) to a railroad spike found 0.2' (foot) below grade at the Northeast corner of a 1.08 acre tract also conveyed to Mark A. Jones by Deed recorded in Official record 11, Page 65, Tract Two, of the Logan County Records, said railroad spike found 0.2' (foot) below grade being the PRINCIPLE PLACE OF BEGINNING for the tract hereinafter described;

thence continuing with the centerline of Township Road 199 S-86°42'00"-E, 150.00' (feet) to a railroad spike set;

thence S-3°55'59"-W, 450.00' (feet) to an iron bar set, passing for reference an iron bar set on the right-of-way line of Township Road 199 at 20.00' (feet);

thence N-86°42'00"-W, 150.00' (feet) to an iron bar set on the East line of aforementioned Mark A. Jones 1.08 acre tract:

thence with the East line of said Mark A. Jones 1.08 acre tract, N-3°55'59"-E, 450.00' (feet) to the place of beginning, passing for reference an iron bar set at 430.75' (feet) and also passing for reference the right-of-way line of Township Road 199 at 430.00' (feet).

Containing 1.549 acre, 0.069 acre of which is within the road right-of-way, but being subject to the rights of all legal highways and all easements of record.






