



Thence *North 05°47'58" East 2684.28 feet*, entering Logan County, following the west line of said Section 34, the east line of said Section 4, the east line of said 8.25 acre tract, after passing the northeast corner of said 8.25 acre tract crossing said original 60 acre tract, and following a portion of the east line of Marvin W. McCulley and Becky E. McCully's original 23 acre Tract II described in Official Record 218, page 482, passing at 2544.98 feet a magnetic nail set in the centerline of Township Road 295, to a point in a ditch, said point being at the southeast corner of Marvin W. McCulley and Becky E. McCully's original 160 acre Tract I described in Official Record 218, page 482, and at the southwest corner of Robert J. Pool, Joy Ann Pool, and Brooks R. Pool's 100 acre tract described in Official Record 479, page 550;

Thence *South 84°03'41" East 276.33 feet*, entering said Section 34, following the north line of said original 60 acre tract, and the south line of said 100 acre tract, passing at 15.00 feet an iron pin set, to a magnetic nail found in the centerline of Township Road 295 and at the northwest corner of Don L. Baughman's 82 acre Parcel One, Second Tract, described in Official Record 950, page 486;

Thence *South 5°57'25" West 2685.10 feet*, following the east line of said original 60 acre tract and the west line of said 82 acre tract, passing at 20.16 feet an iron pin set, to a 5/8 inch iron pin found in the south line of Logan County and said Section 34, in the north line of Champaign County and said Section 33, and in the north line of said 86.682 acre tract;



Thence *North* 83°53'05" West 268.96 feet, following a south line of said original 60 acre tract, the south line of Logan County and said Section 34, and following the north line of said 86.682 acre tract, the north line of Champaign County and said Section 33, to the place of beginning, containing 16.803 acres, more or less, and being subject to all valid easements and restrictions of record. Of the above described 16.803 acre tract, 0.265 acre is within the right of way of Township Road 295.
