LEGAL DESCRIPTION STORM SEWER EASEMENT 99491.02

BEING A 25-FOOT WIDE STORM SEWER EASEMENT OUT OF THE RIVERSIDE BOARD OF EDUCATION'S 45.54 ACRE TRACT AS RECORDED IN OFFICIAL RECORDS VOLUME 254, PAGE 574, OF THE LOGAN COUNTY RECORDER'S DEED RECORDS, IN SECTION 7, TOWN 2, RANGE 14, MIAMI TOWNSHIP, VILLAGE OF DEGRAFF, LOGAN COUNTY, OHIO, AND THE CENTERLINE OF SAID EASEMENT BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

Commencing for reference at a point at the northwest corner of the intersection of the north line of Moore Street and the west line of a ten-foot wide alley, said point being the northwest corner of Lippincotts Second Addition to the Village of DeGraff, (Plat Cabinet A, Slide 85) said point also being the southwest corner of the Riverside Local School District of Logan County, Ohio's 3.86 acre tract as described in Deed Book Volume 322, Page 549;

Thence, South 03° 15' 00" West, 10.50 feet with the west line of aforesaid ten-foot wide alley to a point at the True Place of Beginning of the centerline of the 25-foot wide storm sewer easement;


Thence, with the centerline of said easement the following two courses:

North 86° 52' 13" West, 598.62 feet to a point;

North 83° 28' 02" West, 732.31 feet to a point at its terminus on the west line of aforesaid Riverside Board of Education lands, containing 0.764 acres, more or less, and subject to all existing rights-of-way, easements, and restrictions of record. See attachment, Exhibit "A" for a pictorial description.

In addition, a temporary construction easement is granted for construction purposes, said temporary easement being more particularly described as follows:

Being a 15-foot temporary easement for construction purposes lying south of and adjoining the south line of the above described 25 foot storm sewer easement and being as shown on the attached Exhibit "A".




