

The following described lands situated in Section 16, Town 5, Range 13, Monroe Township, Logan County, Ohio, bounded and described as follows:-

Beginning bat an iron bar in the Ludlow line said bar being N.14 W. 459.5' from a stake at the intersection of the Ludlow line with the center of the West Liberty and Mac-O-Chee Pike, thence deflecting 35° 20' left and running 342.0 feet to an iron bar, thence deflecting 51° 50' right and running 132.0 feet to an iron bar, thence deflecting 21° 30' right and running 252.1 feet to an iron bar in the Ludlow line, thence deflecting 141° 32' right and running with the Ludlow line 607.0 feet to the place of beginning, containing 1.52 acres.





Mac-O-Chee Properties, LLC 10.7612 ACRES

Situated in the State of Ohio, County of Logan, Township of Monroe, being part of Virginia Military Survey (VMS) #4479 and being part of an original 108 acre tract as described in the deed to Samuel J. Plank, recorded in DB 384 Page 366-369, Parcel no. 2 (record reference to those of the Recorder's Office Logan County, Ohio), and being more particularly described as follows:

Commencing from a railroad spike found at the intersection the centerline of County Road 1, Ludlow's Line and centerline of State Route 287 (60' R/W) also being the southwest corner of a 4.00 acre tract owned by Mac-O-Chee Properties, LLC recorded in OR 1372 Page 027, Tract II;

thence, easterly along said centerline of S.R. 287 and the south line of said Mac-O-Chee tract, North 80°07'35" East, a distance of 666.96 feet to a Railroad Spike found at the southeast corner of a 4.14 acre tract owned by Mac-O-Chee Properties, LLC recorded in OR 1372 Page 027, Tract I also being the southwest corner of said Plank tract, said point being the True Point of Beginning,

thence, northerly along the east line of said 4.14 acre tract, North 12°13'04" West, a distance of 540.15 feet to a 5/8" Iron Pin set, (passing a 5/8" Iron Pin set at 30.03 feet);

thence, easterly through said 108 acre tract, North 80°22'08" East, a distance of 909.76 feet to a 4" Metal Fence Post found, (referenced by 5/8" Iron Pin with Cap found, North 52°35'32" East, 1.17 feet), also being the northwest corner of 5.236 acre tract owned by Kerry V. Lyons, et ux, recorded in OR 61 Page 627;

thence, southerly along the west line of said Lyons tract, South 03°31'34" East, a distance of 542.68 feet to a 5/8" Iron Pin set in the centerline of said S.R. 287, being the southwest corner of said Lyons tract, (passing a 5/8" Iron Pin with Cap #4792 found at 512.34 feet);

thence, westerly along said centerline of S.R. 287, South 80°22'08" West, a distance of 827.66 feet to a 5/8" Iron Pin set, to the Place of Beginning, containing 10.7612 acres (containing 0.5715 acres in right of way) of land more or less.

Subject, however, to all legal restrictions/ rights-of-way of previous record.

The platted bearing for the centerline of State Route 287 is assumed to be South 80°22'08" West, based on NAD 83 Ohio North Zone using ODOT VRS (2018), and is the reference meridian for the forgoing description. Iron pins called for as set are 5/8" Dia., thirty (30) inches in length, driven flush with the ground, and capped with a yellow plastic plug inscribed "P.S. 8603."

LEGAL DESCRIPTION FOR PLANK'S 1.383 ACRE TRACT

Being situate in the State of Ohio, County of Logan, Monroe Township, and being a part of Virginia Military Survey Number 4479, and being more particularly described as follows:

Beginning for reference at a railroad spike found at the intersection of the centerline of County Road 1, and State route 245, 60'(feet) wide right-of-way, (Ludlow Line) with the centerline of State Route 287, 60'(feet) wide right-of-way;

Thence with the centerline of said State Route 287, N-80°07′30″-E, 666.96′(feet) to a railroad spike found at the southwest corner of a 10.7612 acre tract conveyed to Mac-O-Chee Properties, LLC. by deed recorded in Official Record 1404, Page 5572;

Thence, with the west line of said 10.7612 acre tract, N-12°11′56″-W, 540.13′(feet) to an iron bar set at the northwest corner thereof at the **PRINCIPLE PLACE OF BEGINNING** for the tract hereinafter described, passing for reference an iron bar found at 30.03′(feet);

Thence with the east line of a 4.14 acre tract conveyed to Mac-O-Chee Properties, LLC. by deed recorded in Official Record 1404, Page 5574, Tract 1, N-12°11′56″-W, 120.00′(feet) to an iron bar set;

Thence, N-77°48'04"-E, 75.00'(feet) to an iron bar set;

Thence, S-12°11'56"-E, 63.34'(feet) to an iron bar set;

Thence N-80°23′39″-E, 868.80′(feet) to an iron bar set on the west line of a 1.875 acre tract conveyed to Gerald A. Kahle by deed recorded in Official Record 1034, Page 170;

Thence the west line of said Kahle, S-18°15′03″-W, 67.86′(feet), to a metal post found at the southwest corner thereof;

Thence with the north line of said 10.7612 acre tract, S-80°23′39″-W, 909.45′(feet), to the place of beginning;

Containing 1.383 acres, being subject to the rights of all legal highways and all easements of record.


