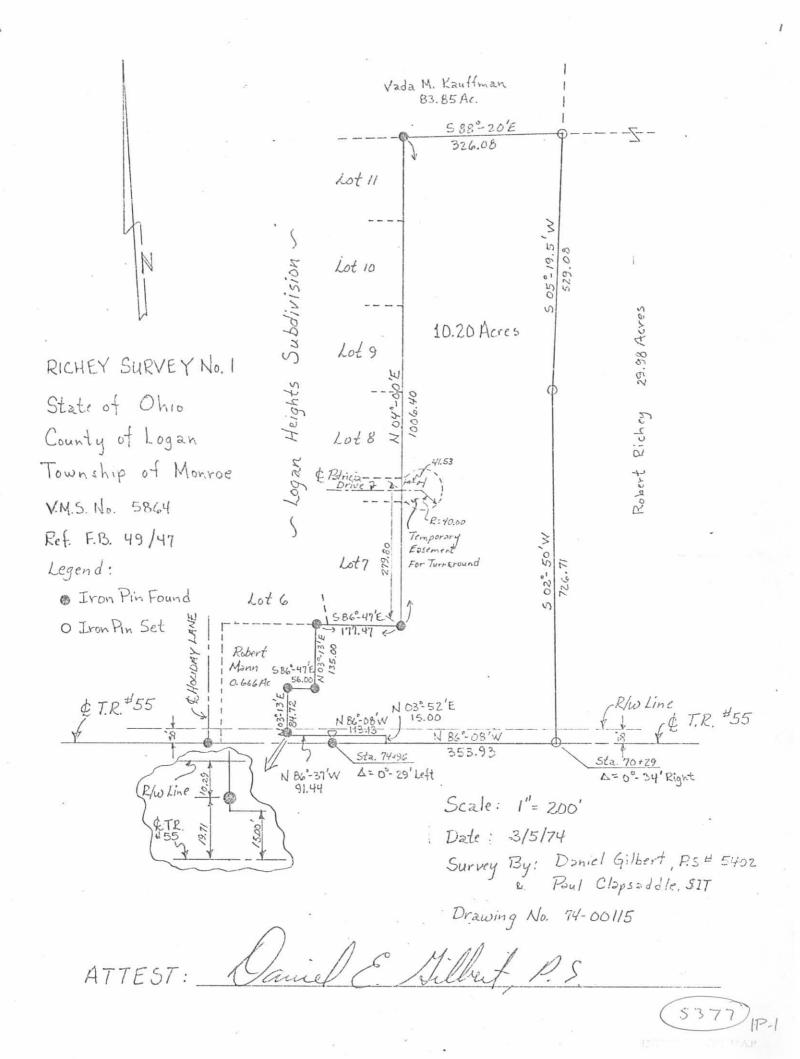

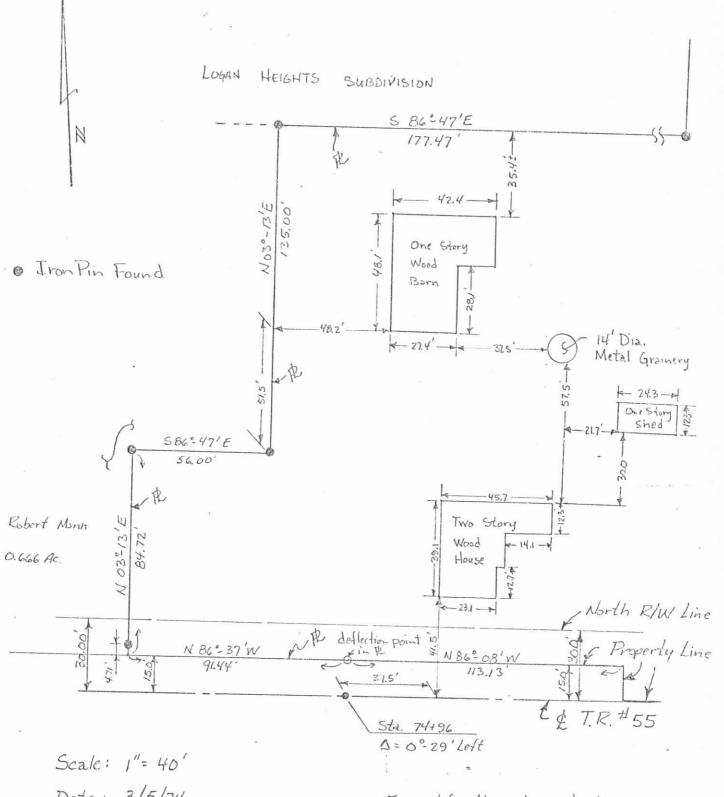

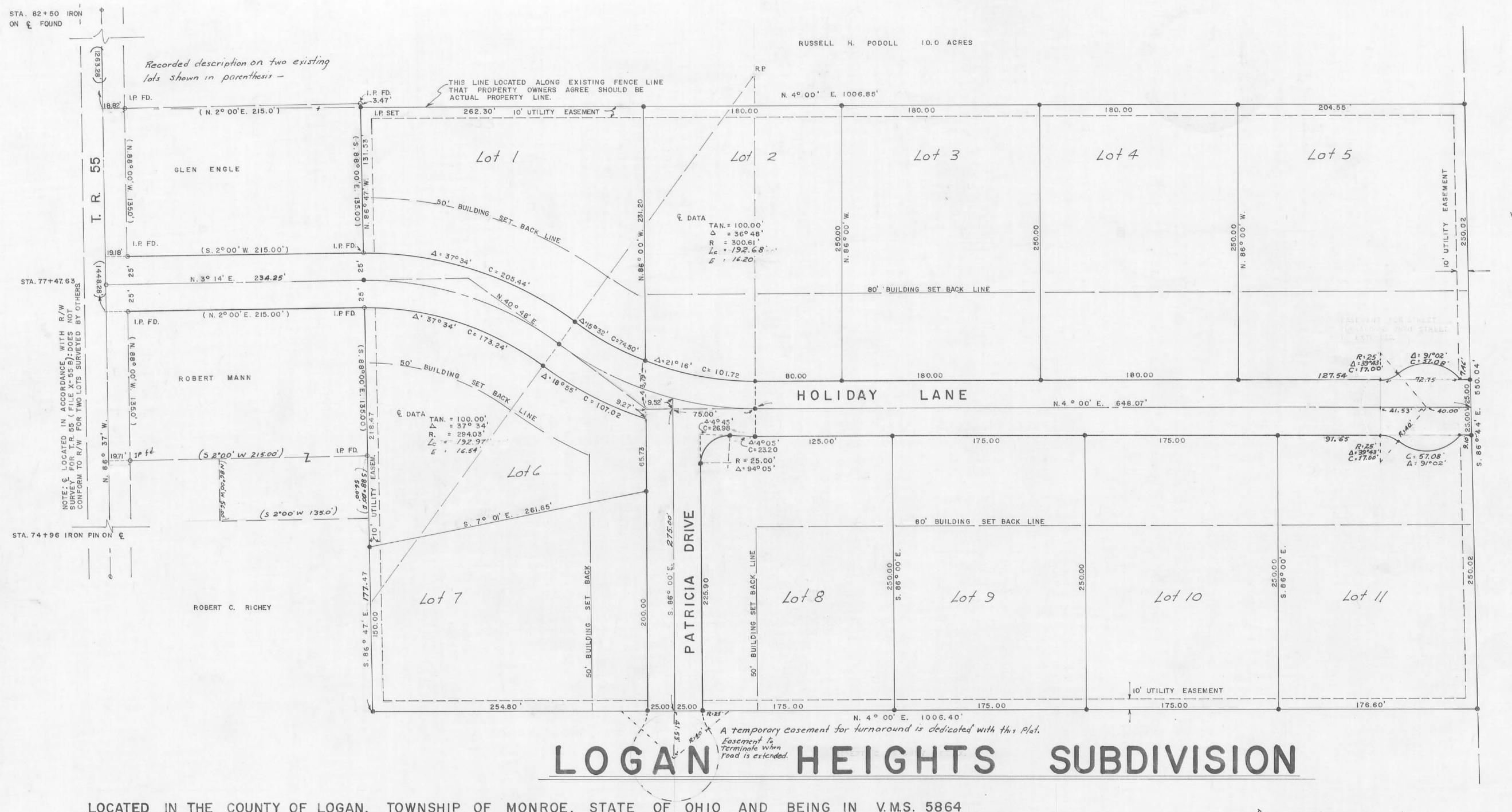

COVENANTS AND RESTRICTIONS

- I. ALL LOTS IN THIS SUBDIVISION ARE DESIGNATED AS SINGLE FAMILY RESIDENTIAL LOTS, AND NOT MORE THAN ONE STRUCTURE SHALL BE USED FOR RESIDENTIAL PURPOSES. NO LOT SHALL BE SUB-DIVIDED INTO PARCELS FOR ADDITIONAL RESIDENTIAL PURPOSES.
- 2. NO SINGLE DWELLING HOUSE SHALL BE ERECTED CONTAINING LESS THAN 1400 SQUARE FEET OF FLOOR AREA IF MORE THAN A ONE STORY HOUSE, OR LESS THAN 1000 SQUARE FEET OF FLOOR AREA IF A ONE STORY HOUSE.
- 3. NO NOXIOUS OR OFFENSIVE TRADE OR ACTIVITY SHALL BE CARRIED ON UPON ANY LOT AND NO CONDITION SHALL BE ALLOWED TO EXIST WHICH MAY BE OR BECOME A NUISANCE OR AN ANNOYANCE TO THE NEIGHBORHOOD.
- 4. NO SIGN OR BILLBOARD .SHALL BE ERECTED ON ANY LOT, EXCEPT FOR A PROFESSIONAL SIGN OF NOT MORE THAN ONE SQUARE FOOT IN AREA AND EXCEPT FOR "FOR SALE" OR "FOR RENT" SIGNS NOT TO EXCEED FIVE SQUARE FEET IN AREA. ADVERTISING SIGNS DURING THE CONSTRUCTION AND SALE PERIOD MAY BE USED BY THE BUILDER.
- 5. THESE COVENANTS AND RESTRICTIONS ARE FOR THE BENEFIT OF ALL LOT OWNERS AND ARE TO RUN WITH THE LAND, BINDING ON ALL PARTIES AND ALL PERSONS CLAIMING UNDER THEM UNTIL JUNE 1990, AT WHICH TIME SAID COVENANTS ARE TO BE EXTENDED AUTOMATICALLY FOR PERIODS OF TEN YEARS, UNLESS BY VOTE OF THE THEN OWNERS OF THE LOTS, A MAJORITY OF SAID LOT OWNERS AGREES TO CHANGE SAID COVENANTS. IN WHOLE OR IN PART.
- 6. THESE COVENANTS AND RESTRICTIONS SHALL BE ENFORCEBLE BY INJUNCTION OR OTHERWISE, BY THE GRANTOR, HIS HEIRS, SUCESSORS, OR ASSIGNS, OR BY ANY LOT OWNER AT THE TIME OF ANY VIOLATION.

- 8. NO HOUSE TRAILERS OR OTHER OUTBUILDING SHALL BE USED AS A RESIDENCE TEMPORARILY OR PERMANENTLY.
- 9. EASEMENTS FOR INSTALLATION AND MAINTENANCE OF UTILITIES AND DRAINAGE FACILITIES ARE HEREBY RESERVED AS SHOWN.
- IO. NO LOT SHALL BE USED AS A DUMPING GROUND FOR RUBBISH, TRASH, GARBAGE OR OTHER WASTE MATERIAL. ALL SUCH WASTE SHALL BE KEPT IN SANITARY CONTAINERS AND SHALL NOT BE ALLOWED TO ACCUMULATE.
