ROY L. BRAGG 4.756 ACRES

Lying in Virginia Military Surveys 4493-4525 and 6516, Monroe Township, Logan County, Ohio.

Being all of the Roy L. Bragg 1.052 acre tract and part of the 8.58 acre tract as deeded and described in Official Record 121, Page 15, Tracts IV and III of the Logan County Records of Deeds and being more particularly described as follows:

Beginning at a railroad spike found at the northwest corner of the said 8.58 acre tract and being on the center-line of County Highway 47 and the north line of Virginia Military Survey 6516.

THENCE, with the center-line of County Highway 47, N 51°-12'-00" E, a distance of 197.04 feet to a PK nail set at the TRUE POINT OF BEGINNING.

THENCE, with the center-line of County Highway 47 (66 feet wide), N 51°-12'-00" E, a distance of 356.85 feet to a bridge spike found.

THENCE, with the east line of the aforesaid 1.052 acre tract and a west line of the Patricia McClure 138.538 acre tract (O.R. 183, Pg. 742), S 16°-05'-00" E, a distance of 927.43 feet to a 5/8 inch iron rod found.

THENCE, with the south line of the said 1.052 acre tract and the south line of the aforementioned 8.58 acre tract, S 73°-55'-00" W, a distance of 200.00 feet to a 5/8 inch iron rod set, passing a 5/8 inch iron rod found at 50.00 feet.

THENCE, N 18°-40'-21" W, a distance of 623.15 feet to a 5/8 inch iron rod set.

THENCE, S 58°-01'-20" W, a distance of 50.49 feet to a 5/8 inch iron rod set.

THENCE, N 32°-15'-03" W, a distance of 188.39 feet to the point of beginning.

Containing 4.758 acres of which there is the following acreage breakdown:

The basis for bearings is the center-line of County Road 47 being N 51°-12'-00" E, and all other bearings are from angles and distances measured in a field survey by Lee Surveying and Mapping Company on November 15, 1995.

The 1.052 acre tract has 0.860 acre in V.M.S. 6516 and 0.192 acre in V.M.S. 4493-

4525 with 0.041 acre in the highway right-of-way and;
The 3.706 acres out of the 8.58 acre tract have 2.965 acres in V.M.S. 6516 and 0.741 acre in V.M.S. 4493-4525 with 0.225 acre within the highway right-of-way.



LEGAL DESCRIPTION FOR McCLURE'S 37.972 ACRE TRACT

Being situate in the State of Ohio, County of Logan, Township of Monroe, and being a part of Virginia Military Surveys 6516 and 4493, and being more particularly described as follows:

Beginning for reference at a ½" diameter iron bar found at the intersection of the centerlines of Township Road 166 (60' right-of-way) and County Road 47 (60' right-of-way) at Station 57+47 (F.B. 559, P. 15);

thence with the centerline of County Road 47 the following three (3) courses:

- 1. S-53°18'29"-W, 859.72'(feet) to a 1/2" diameter iron bar found at Station 48+87.1;
- 2. S-52°11′20″-W, 1085.97′(feet) to a ½″ diameter iron bar found at Station 38+01;
- 3. S-51°56′18″-W, 55.02′(feet) to a Mag Nail set at the **PRINCIPLE PLACE OF BEGINNING** for the tract hereinafter described;

thence S-15°18′06″-E, 2377.48′(feet) to an iron bar set on the North line of a 159.30 acre tract conveyed to Jeff O. Harr by deed recorded in Official Record 878, Page 479, Tract II, also being on a Southerly line of V.M.S. 6516 which is also a Northerly line of V.M.S. 4479, passing for reference an iron bar set on the right-of-way line of County Road 47 at 32.53′(feet);

thence with the V.M.S. line and the North line of Harr's tract, S-33°10′58″-W, 552.32′(feet) to a 5/8″ diameter iron bar found at a Northeast corner of a 97.927 acre tract conveyed to Julia B. Yoder, Trustee, by deed recorded in Official Record 920, Page 761, Tract I;

thence with the bounds of Yoder's tract the following two (2) courses:

- 1. S-33°55'46"-W, 778.82'(feet) to a 5/8" diameter iron bar found;
- 2. N-14°47′59″-W, 1217.00′(feet) to an iron bar set on at the Southeast corner of a 23.78 acre tract conveyed to Robert Eugene McClure by deed recorded in Official Record 1164, Page 140, Parcel II, Tract, III:

thence N-73°52'45"-E, 542.80'(feet) to an iron bar set;

thence with the East line of a 1.052 acre tract conveyed to Roy L. Bragg by deed recorded in Official Record 121, Page 15, Tract IV, and the East line thereof projected, N-15°18′06″-W, 1838.64′(feet) to a Mag Nail set on the centerline of aforementioned County Road 47, passing for reference a 5/8″ diameter iron bar found at the Southeast corner of the 1.052 acre tract at 910.62′(feet), the right-of-way line of County Road 47 at 1806.11′(feet), and a 5/8″ diameter iron bar found at 1810.94′(feet);

thence with the centerline of County Road 47, N-51°56′18″-E, 488.00′(feet) to the place of beginning.

Containing 37.972 acres, 0.336 acre of which is within the Road right-of-way, 3.017 acres of which are a part of V.M.S. 4493, and 34.955 acres of which are a part of V.M.S. 6516, but being subject to the rights of all legal highways and all easements of record.

Being a part of a 56.198 acre tract conveyed to Robert Eugene McClure by deed recorded in Official Record 1164, age 140, Parcel II, Tract II, of the Logan County Records.

All iron bars set are 5/8"x30" iron re-bar with a yellow plastic cap stamped "EDWARDS PS7574". Bearings are based on the centerline of County Road 47 per an assumed bearing of N-51°56'18"-E.
