THENCE, S 17°-57'-05" E, a distance of 566.99 feet to an iron rod set on the grantor's south line on the extended east line of the aforementioned 16.5 foot lane. This point also being the northwest corner of the V.B. Smith 38.4 acre tract (Champaign County Volume 236, Page 393).

THENCE, with the west line of said 38.4 acres, the same being the east line of said lane, S 16°-27'-20" E, a distance of 825.68 feet to a railroad spike set on the center-line of Mt. Tabor Road.
