Beginning at a railroad spike found at the intersection of the centerlines of Mount Tabor Road (County Highway 108) (60' right-of-way) and Township Road 169 (60' right-of-way);

thence with the centerline of Mount Tabor Road S-74°00'00"-W, 1237.92' (feet) to a railroad spike set;

thence N-16°20'25"-W, 830.44' (feet) to an iron bar set on the South line of an original 98.10 acre tract conveyed to Betty J. Smith by Deed recorded in Deed Volume 188, Page 1070, of the Champaign County Deed Records and in Deed Volume 294, Page 337, of the Logan County Deed Records, passing for reference an iron bar set on the right-of-way line of Mount Tabor Road AT 30.00'(FEET) and crossing from Champaign County into Logan County at 731.19' (feet);

thence with the South line of said Betty Smith's tract, N-74°18'33"-E, 1335.89' (feet) to a railroad spike set on the centerline of aforementioned Township Road 169, passing for reference an iron bar set on the right-of-way line of Township Road 169 at 1305.72' (feet);

thence with the centerline of Township Road 169 S-9°33'12"-E, 828.45' (feet) to the place of beginning, passing for reference a 5/8" diameter iron bar in a monument box found on the Logan-Champaign County Line at 582.79' (feet).

Containing a total of 24.431 acres, 1.404 acre of which is within the roads rights-of-ways, 10.329 acres of which is within Monroe Township of Logan County and 14.102 acres of which is within Salem Township of Champaign County, but being subject to the rights of all legal highways and all easements of record.




