Thence *South 86°39'49" East 48.18 feet*, following a south line of Stanley and Jean K. Leininger's 25 acre Parcel One, Tract I described in Deed Record 285, page 215 and a north line of said 429 acre tract, the north line of V.M.S. 5088, and the south line of V.M.S. 5091, to an iron pin set;

Thence *North 06°35'14" West 892.21 feet*, following a west line of said 429 acre tract and an east line of said 25 acre tract, passing at 871.82 feet an iron pin set, to the *place of beginning, containing 418.967 acres*, more or less, and being subject to all valid easements and restrictions of record. Of the above described 418.967 acre tract, 1.434 acre is within the right of way of Township Road 129.
