





Thence North 19°40'13" West (assumed bearing) 15.00 feet, following the centerline of State Route 292 and an east line of said 119.586 acre tract, to a magnetic nail found at the southeast corner of said 1.140 acre tract, said magnetic nail marking the *place of beginning*;

Thence **South** 70°46'03" West 212.52 feet, following a south line of said 1.140 acre tract and a north line of said 119.586 acre tract, passing a 5/8 inch iron pin found at 30.00 feet, to a 5/8 inch iron pin found;



Thence *North 84°27'29" West 1581.80 feet*, following a south line of said 0.59 acre tract and a north line of said 156.68 acre tract, to an iron pin set;

Thence *North 00°46'30" East 693.66 feet*, crossing said 0.59 acre tract and entering said original 85.35 acre tract, to an iron pin set;




