





ENVIRONMENTAL COVENANT EASEMENT DESCRIPTION

Situate in the State of Ohio, Logan County, Perry Township, part of Virginia Military Survey Nos. 4811 & 4689 and being part of the 4273.520 acres conveyed to "HONDA OF AMERICA, MFG., INC.", (hereinafter referred to as Grantor) as described in Governor's Deed recorded in Official Record 56, Page 241 of the Logan County's Recorder's Office and being more particularly described as follows:

COMMENCING at the intersection of the centerline of County Road 154 at station 16+38.94 being described in a Road Record prepared by the Logan County Engineers Office in May 1995 and on file in the Logan County Map Room file number R-9024 and the North line of said 4273.520 acre Grantors lands;

THENCE on the North line of the Grantor's lands as described in said Governor's Deed the following four (4) courses:

- On a tangent curve to the Left with a Radius of 8,627.42 feet, an Arc distance of 27.99 feet, a Chord Bearing of South 81 degrees 03 minutes 39 seconds West, with a Chord Distance of 27.99 feet to a point;
- 2) South 32 degrees 51 minutes 06 seconds East for a distance of 1.66 feet to a point;
- 3) South 79 degrees 57 minutes 47 seconds West for a distance of 1,436.86 feet to a point;
- 4) South 33 degrees 04 minutes 42 seconds East for a distance of 55.97 feet to a point;




