

Beginning for reference at a 1 inch iron pin found in a monument box at the intersection of the centerline of County Road #2(60 feet wide) with the centerline of Township Road #131(60 feet wide), said iron pin marking the southeast corner of the Trustees of the Methodist Episcopal Church's 0.25 acre tract described in Deed Volume 36, page 200;

Thence North 88°17'00" West (assumed bearing) 129.32 feet, following the centerline of County Road #2 and south line of said 0.25 acre tract, to a railroad spike found in the centerline of County Road #2 at the southwest corner of said 0.25 acre tract and at an angle point in the east line of said 147.84 acre tract, said spike marking **the place of beginning**;


