Beginning at a monument box with an old wood stake found located at the intersection of the centerline of County Road 2 (R/W varies) at Station 384+87.5 (Field Book 579, page 74) with the centerline of County Road 142 (60 ft. R/W) at Station 104+95 (Field Book 615, page 37), said point being the northeast corner of hereinafter described 77.326 acre tract, and the true point of beginning;

Thence along the centerline of County Road 142 the following courses and distances:

South 13 deg. 38 min. 31 sec. West for a distance of 790.98 feet to an 1-1/2 inch square iron bar found at an angle point, being Station 97+04 (Field Book 615, page 36);

South 17 deg. 21 min. 31 sec. West for a distance of 171.60 feet to a survey nail set at an angle point, being Station 95+32.4;

South 21 deg. 36 min. 15 sec. West for a distance of 332.23 feet to an 1-1/2 inch square iron bar found at an angle point, being Station 92+00;

South 20 deg. 08 min. 38 sec. West for a distance of 319.40 feet to a survey nail set;

Thence crossing grantor's tract the following courses and distances:

North 69 deg. 51 min. 22 sec. West for a distance of 200.00 feet to an iron pin set (passing over an iron pin set at a distance of 30.00 feet);

South 20 deg. 08 min. 38 sec. West for a distance of 480.00 feet to an iron pin set;

South 69 deg. 51 min. 22 sec. East for a distance of 200.00 feet to a survey nail set located on County Road 142 centerline (passing over an iron pin set at a distance of 170.00 feet);
