Beginning at a MAG nail set at the southeast corner of Section 8 and being the intersection of center-lines of Township Road 43 and Ohio Route 235.

THENCE, with the east line of Section 8 and the center-line of Ohio Route 235, N 0°-47'-16" E, a distance of 265.71 feet to a railroad spike set at the TRUE POINT OF BEGINNING.

THENCE, with the north line of the Richard S. Wilgus 2.00 acre tract (O.R. 105, Pg. 370), N 89°-38'-54" W, a distance of 410.76 feet to a 5/8 inch iron rod set.

THENCE, N 0°-47'-16" E, a distance of 159.08 feet to a 5/8 inch iron rod set.

THENCE, S 89°-38'-54" E, a distance of 410.76 feet to a railroad spike set.

THENCE, with the east line of Section 8 and the center-line of Ohio Route 235 (60 feet wide), S 0°-47'-16" W, a distance of 159.08 feet to the point of beginning.

Containing 1.500 acres of which 0.110 acre is within the highway right-of-way.

The basis for bearings is the east line of Section 8 being N 0°-47'-16" E, and all other bearings are from angles and distances measured in a field survey by Lee Surveying and Mapping Co., Inc. on January 7, 1997.


