
WATKINS SURVEY SEC. 9, T-1, R-8 PLEASANT TOWNSHIP


Beginning at an iron bar in the south line of said Section 9, T-1, R-8 at the southwest corner of Lester Covault's 30.00 acre tract, said iron bar being S. 89°42' W. 702.4 feet from an iron bar in the center of County Highway No. 34 at the southeast corner of said section; thence with the south line of said Section 9, S. 89°42' W 150.6 feet to an iron bar at the southeast corner of Samuel R. Doak's 10.00 acre tract; thence with said Doak's east line N. 0°02' E. 577.5 feet to an iron bar at the northeast corner of said tract; thence with said Doak's north line S. 89°42' W. 750.7 feet to an iron bar at the northwest corner of said tract; thence with said Doak's west line s. 0°02' W. 577.5 feet to an iron bar in the south line of said Section 9 at the southwest corner of said tract; thence with said section line S. 89°42' W. 608.4 feet to an iron bar at the southeast corner of N. J. Moore's 9.00 acre tract; thence with said Moore's east line N. 0°32' W. 1802.4 feet to an iron pin in the center of State Route 47 at the northeast corner of said tract; thence with the centerline of said State Route 47, N. 86°40' E. 894.2 feet to an iron pin; thence with said centerline N. 86°02' E. 626.5 feet

to an iron pin at the northwest corner of Lester Covault's 30.00 acre tract; thence with said Covault's west line S. 0°02' W. 1890.3 feet to the place of beginning.

Thence with the center of State Route 47 S 87°-21' W 1337.0 feet to an angle.

Thence continuing with the center of State Route 47 S 87 -58' W 224.5 feet to an iron. Said iron is the true point of beginning for this description.

Thence N 1 -19* W 182.4 feet to an iron, passing thru an iron at 30.0 feet.


Thence S 87 -44' W 144.4 feet to a post.

Thence with the center of State Route 47 N 87°-58° E 148.5 feet to the place of beginning.


Containing 0.61 of an acre more or less. Being surveyed from a 29.57 acre tract.
