
Logansville Christian Church Survey Sec. 9 T-2 R-14 Pleasant Township September 23, 1978

Beginning at an iron pipe in the south line of State Route 47 at the northeast corner of lot 63 in the Village of Logansville as shown in Logan County Recorders Plat Book B, Volume 2, Range 30; thence with the east line of said lot 63 S.30°00'E. 132.0 feet to an iron pipe at the southeast corner of said lot; thence N.60°00'E. 66.0 feet to an iron bar; thence N.30°00'W. 160.9 feet to a point in the center of said State Route 47, passing an iron pipe at 132.0 feet; thence with the centerline of said S. R. 47 S.60°33'W. 66.0 feet; thence S.30°00'E. 29.5 feet to the place of beginning.

SURVEY FOR THE TRUSTEES OF THE LOGANSVILLE COMMUNITY CHURCH 2.003 Acres January 19, 2022

The following described 2.003 acre tract is situated in the State of Ohio, County of Logan, Township of Pleasant, and Section 9, Town 2, Range 14, B.T.M.R.S., being part of David P. and Nancy J. Knight's 44.01 acre tract described in O.R. 835, page 389, Parcel II and said 2.003 acre tract being more particularly described as follows:

Beginning for reference in Logansville at a 1 inch iron pin found at the intersection of the centerline of State Route 47 (60') with the centerline of County Road 24 (60');

Thence North 60°25'31" East 552.90 feet, following the centerline of State Route 47, to a magnetic nail set at the northeast corner of the Logansville Christian Church's 0.24 acre tract described in D.R. 380, page 566, and at a northwest corner of said 44.01 acre tract, said magnetic nail marking the *place of beginning*;

Thence *North 60°25'31" East 224.66 feet*, following the centerline of State Route 47 and a northwest line of said 44.01 acre tract, to a magnetic nail set;

Thence South 29°49'43" East 387.86 feet, departing from the centerline of said Road and entering said 44.01 acre tract, passing at 30.00 feet an iron pin set, to an iron pin set;

Thence South 60°08'22" West 224.66 feet, continuing through said 44.01 acre tract, to a 5/8 inch iron pin found at the southeast corner of The Trustees of the Logansville Community Church's original 3.000 acre tract described in O.R. 174, page 342;

Thence North 29°49'43" West 229.73 feet, following a southwest line of said 44.01 acre tract and the northeast line of said 3.000 acre tract, to a 1 inch iron pin found at the southeast corner of said 0.24 acre tract;

Thence North 29°49'43" West 159.25 feet, following a southwest line of said 44.01 acre tract and the northeast line of said 0.24 acre tract, passing at 129.25 feet an iron pin set, to the place of beginning, containing 2.003 acres, more or less, and being subject to all valid easements and restrictions of record. Of the above described 2.003 acre tract, 0.155 acre is within the right of way of State Route 47.




