Thence parallel to the centerline of T.R. 35, N. 1° - 12' - 00" E., 92.09 feet to a point.

Thence perpendicular to the centerline of T.R. 35, S.88° - 48' - 00" E., 10.00 feet to a point on the West right-of-way line of T.R. 35.

Thence with the West right-of-way line of T.R. 35, S. 1° - 12' - 00" W., 92.09 feet to the point of the beginning.
