LEGAL DESCRIPTION FOR CONLEY'S 9.888 ACRE TRACT

. Being situate in the State of Ohio, County of Logan, Township of Pleasant, and being a part of the Southwest quarter of Section 32, Town 3, Range 14, and being more particularly described as follows:

Beginning for reference at a 5/8" diameter iron bar found at the intersection of the centerlines of Township Road 208 and County Road 11;

thence with the centerline of County Road 11 (60' right-of-way) S-0°24'34"-E, 1422.77' (feet) to a Mag nail set at the **PRINCIPLE PLACE OF BEGINNING** for the tract hereinafter described;

thence S-85°22'02"-E, 360.58' (feet) to an iron bar set, passing for reference the right-of-way line of County Road 11 at 30.12' (feet) and also passing for reference an iron bar set at 31.12' (feet);

thence S-5°26'30"-W, 855.25' (feet) to an iron bar set on the North line of a 5.001 acre tract conveyed to Tom & Tamara Scott by Deed recorded in Official Record 299, Page 551, of the Logan County Records;

thence with the North line of said Scott's tract N-84°33'30"-W, 526.95' (feet) to a railroad spike found on the centerline of aforementioned County Road 11, passing for reference an iron bar set on the right-of-way line of County Road 11 at 496.80' (feet);

thence with the centerline of County Road 11 the following five (5) courses:

- 1. N-0°14'35"-W, 528.84' (feet) to a Mag nail set;
- with a curve to the right having a Delta Angle of 91°38'03" and a Radius of 97.19' (feet), an Arc Distance of 155.43' (feet) to a Mag nail set, the Chord of which bears N-45°34'27"-E, 139.39' (feet);
- 3. S-88°36'32"-E, 50.50' (feet) to a Mag nail set;
- with a curve to the left having a Delta Angle of 91°48'02" and a Radius of 96.91' (feet), an Arc Distance of 155.26' (feet) to a Mag nail set, the Chord of which bears N-45°29'27"-E, 139.18' (feet):
- 5. N-0°24'34"-W, 107.80' (feet) to the place of beginning.

Containing 9.888 acres, 0.687 acre of which is within the road right-of-way, but being subject to the rights of all legal highways and all easements of record.

Being a part of a 137.60 acre tract conveyed to Susan M. Conley & Sandra G. Williams by Deed recorded in Official Record 820, Page 658, Tract 1, of the Logan County Records.
