Lying in Section 23, Town 3, Range 13, Village of Quincy, Miami Township, Logan County, Ohio.

Being the Franklin W. Coy 0.64 acre tract as deeded in Official Record 77, Page 824 of the Logan County Records of Deeds and being more particularly described as follows:

Beginning at a 1 inch square iron bar found at the intersection of center-lines of Mill Street and Miami Street (49.5 feet wide).

THENCE, with the center-line of Miami street, S 5°-34'-00" W, a distance of 387.92 feet to a point.

THENCE, N 84°-26'-58" W, a distance of 24.75 feet to a point at the TRUE POINT OF BEGINNING, referenced by a 5/8 inch iron rod found, N 84°-26'-58" W, a distance of 0.16 feet.

THENCE, with the west right-of-way of Miami street, S 5°-34'-00" W, a distance of 94.72 feet to a 5/8 inch iron rod set.

THENCE, with the north line of the Pearl Louise Heath 0.01 acre tract (O.R. 411, Pg. 691, Third Tract), N 84°-17'-04" W, a distance of 80.74 feet to a 3/4 inch iron rod found.

THENCE, with the west lines of the said 0.01 acre tract and the Pearl Louise Heath 0.073 acre tract (O.R. 411, Pg. 691, First Tract), S 5°-08'-19" W, a distance of 37.28 feet to a 5/8 inch iron rod set.

THENCE, with the northerly right-of-way of a 15.25 feet wide alley, N 84°-02'-31" W, a distance of 89.78 feet to a 5/8 inch iron rod set.

THENCE, with the east right-of-way of a 16.00 feet wide alley, N 5°-37'-44" E, a distance of 131.13 feet to a 3/4 inch iron rod found.

THENCE, with the southerly line of the John S. Hickman 0.367 acre tract (O.R. 295, Pg. 122), S 84°-26'-58" E, a distance of 170.10 feet to the point of beginning, passing a 5/8 inch iron rod found at 169.94 feet.


Containing 0.445 acre.
