WEISKITTLE 0.348 ACRES

Lying in Section 23, Town 3, Range 13, Village of Quincy, Miami Township, Logan County, Ohio.

Being out of the William L. Weiskittle and Suzanne Weiskittle one and one half acre tract as deeded and described in Official Record 216, Pg. 137, Tract III of the Logan County Records of Deeds and being more particularly described as follows:

Beginning at a railroad spike found on the center-line of Main Street on center-line Station 6+62 (Logan County Engineer's Field Book 588, Page 37).

THENCE, N 0°-17'-36" W, a distance of 30.00 feet to a 5/8 inch iron rod set on the north right-of-way of Main Street at the TRUE POINT OF BEGINNING, passing the southeast corner of Lot 1 of the Village of Quincy original plat (Plat Cabinet A, Slide 91) at 28.88 feet.

THENCE, with the east line of Lot 1, N 0°-17'-36" W, a distance of 96.00 feet to a 5/8 inch iron rod set.

THENCE, S 89°-53'-01" E, a distance of 165.00 feet to a 5/8 inch iron rod set.

THENCE, S 5°-41'-03" W, a distance of 96.00 feet to a 5/8 inch iron rod set.

THENCE, with the north right-of-way of Main Street, S 89°-57'-00" W, a distance of 155.00 feet to the point of beginning.

Containing 0.348 acre.

The basis for bearings is the center-line of Main Street, being S 89°-57'-00" W, and all other bearings are from angles and distances measured in a field survey by Lee Surveying and Mapping Co., Inc. on October 3, 2002.

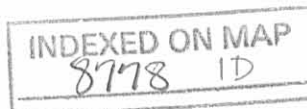

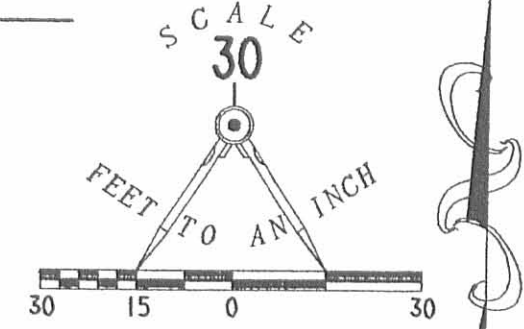

The following described tract is situated in the Village of Quincy, Miami Township, Logan County, State of Ohio. The tract is also located in the northeast corner of the northwest quarter of Section 23, Town 3, Range 13 of the Between the Miami Rivers Survey and is a part of William L. and Suzanne Weiskittle's original 2.75 acre Tract I as recorded in Official Records Volume 216, Page 137.

Commencing at a 1/2 inch diameter iron pipe found at Station 111+39 on the centerline of Main Street (County Highway No. 63) as shown in Field Book 603 on page 14;

Thence South 80° 11' 45" West (This bearing is based on the centerline of Main Street (County Highway No.63) and all other bearings are from angles and distances measured in the field.) with the centerline of Main Street a distance of 18.16 feet to a Mag nail set at the point of beginning of this description;

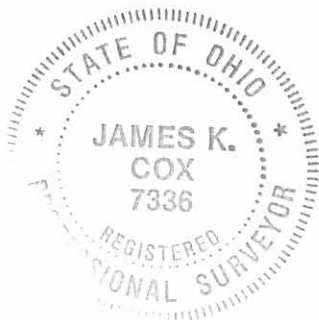
Thence continuing with the centerline of Main Street South 80° 11' 45" West a distance of 156.64 feet to a Mag nail set;

Thence North 1° 15' 36" West a distance of 177.51 feet to a 5/8 inch diameter iron bar set, passing through a 5/8 inch diameter iron bar set on the right of way line at 30.34 feet;

Thence North 88° 44' 24" East a distance of 152.16 feet to a 5/8 inch diameter iron bar set;

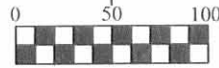

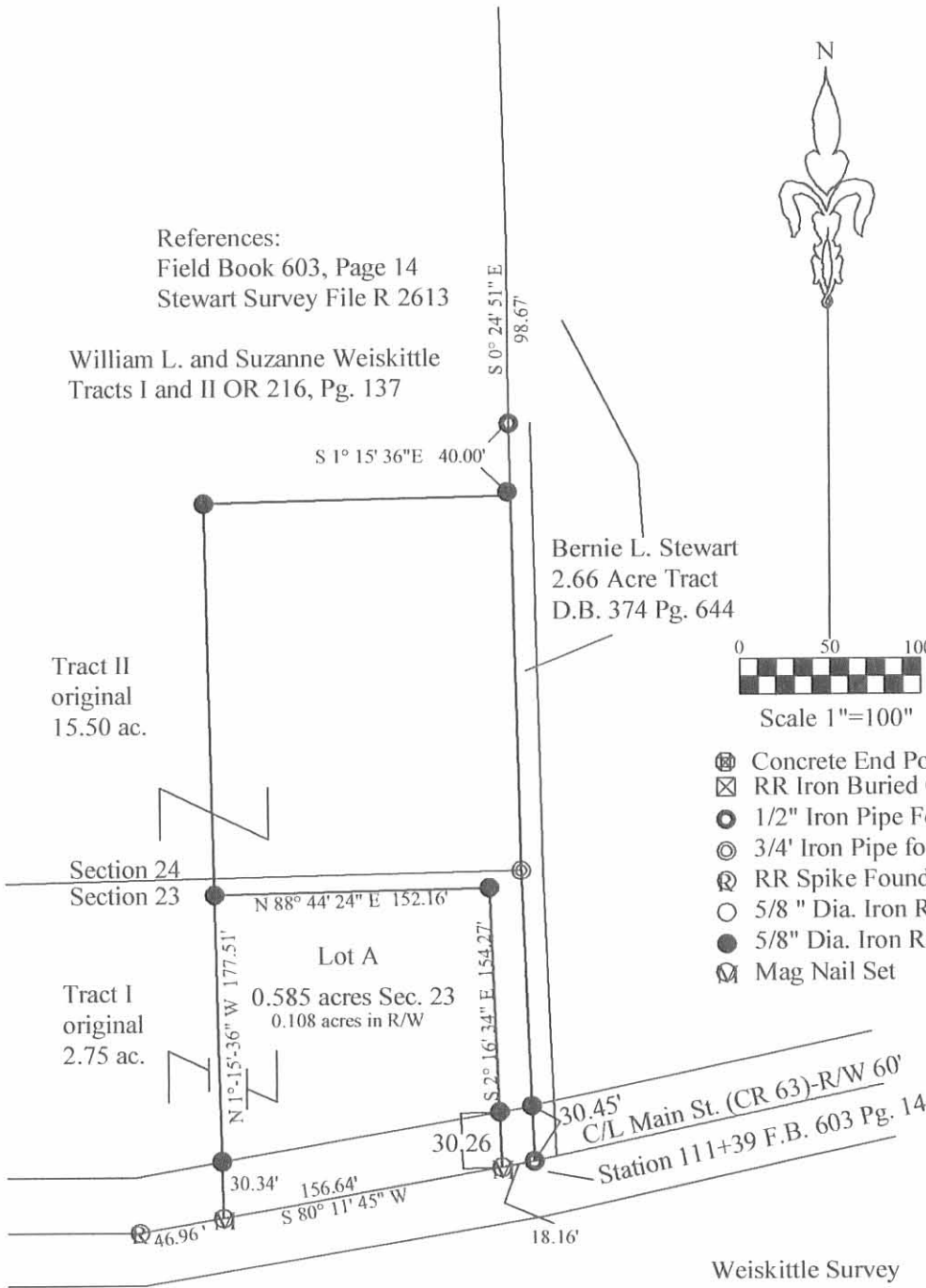

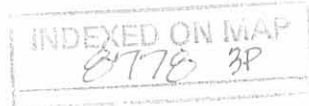

The following described tract is situated in the Village of Quincy, Miami Township, Logan County, State of Ohio. The tract is also located in the northeast corner of the northwest quarter of Section 23, Town 3, Range 13 and in Fractional Section 24, Town 3, Range 13 of the Between the Miami Rivers Survey and is a part of William L. and Suzanne Weiskittle's original 2.75 acre Tract I and original 15.50 acre Tract II as recorded in Official Records Volume 216, Page 137.

Beginning at a ½ inch diameter iron pipe found at Station 111+39 on the centerline of Main Street (County Highway No. 63) as shown in Field Book 603 on page 14, said iron pipe also being the southwest corner of Bernie L. Stewart's 2.66 acre tract as recorded in Deed Book Volume 374, Page 644;

Thence South 80° 11' 45" West (This bearing is based on the centerline of Main Street (County Highway No.63) and all other bearings are from angles and distances measured in the field.) with the centerline of Main Street a distance of 18.16 feet to a Mag nail set;

Thence North 2° 16' 34" West a distance of 154.27 feet to a 5/8 inch diameter iron bar set, passing through a 5/8 inch diameter iron bar set on the right of way line at 30.26 feet;

Thence South 88° 44' 24" West a distance of 152.16 feet to a 5/8 inch diameter iron bar set;

Thence North 1° 15' 36" West a distance of 216.70 feet to a 5/8 inch diameter iron bar set;


Thence North 88° 44' 24" East a distance of 170.00 feet to an iron bar set on the west Line of said Bernie L. Stewart's tract;

Thence with the west line of said Bernie L. Stewart's tract South 1° 15' 36" East a distance of 207.38 feet to a ¾ inch diameter iron pipe found;

Thence continuing with the west line of Bernie Stewart's lot South 2° 16' 34" East a distance of 160.89 feet to the place of beginning, passing through a 5/8 inch diameter iron bar set on the right of way line at 130.44 feet.
