

LEGAL DESCRIPTION WISCHMEYER # 1

BEING A UTILITY EASEMENT OVER, THROUGH, AND ACROSS A 73.306 ACRE TRACT OF LAND OWNED W. WILLIAM WISCHMEYER & BOBBIE L. WILKINS AS DESCRIBED IN OFFICIAL RECORD 912, PAGE 885 OF THE LOGAN COUNTY DEED RECORDS, SITUATE IN VIRGINIA MILITARY SURVEY 9947, RICHLAND TOWNSHIP, LOGAN COUNTY, OHIO AND BEING MORE FULLY DESCRIBED AS FOLLOWS:

Commencing for reference at the southwest corner of a 2.67 acre tract of land owned by Lewis Tracey as described in Deed Volume 369, Page 183 and being a point in the centerline of County Road 38;

thence, South 87°-20'-59" East, 25.08 feet, along the south line of said Tracey tract to a point on the east right-of-way line of County Road 38 and being the principal place of beginning of the easement herein conveyed;

thence, South 87°-20'-59" East, 12.02 feet, to a point;

thence, South 06°-00'-01" West, 416.37 feet, parallel to the east right-of-way line to a point;

thence, South 05°-51'-53" East, 428.40 feet, parallel to the east right-of-way line to a point;

thence, South 47°-57'-52" East, 42.96 feet, to a point:

thence, South 05°-51'-53" East, 85.48 feet, to a point on the north right-of-way line of State Route 366;

thence, North 49°-01'-14" West, 59.65 feet, along the north right-of-way line of State Route 366 to a point on the east right-of-way line of County Road 38;

thence, North 05°-51'-53" West, 503.49 feet, along the east right-of-way line of County Road 38 to a point;

thence, North 06°-00'-01" East, 416.91 feet, along the east right-of-way line of County Road 38 to the principal place of beginning.

Containing 0.312 acres more or less with all being subject to any legal highway and easements of record.

The bearings are based on NAD 83 CORS 96 Adjustment, Ohio North Zone, ODOT VRS CORS Network.
