Being a parcel of land in VMS 12279, McDonald Township, Hardin County and Richland Township, Logan County, Ohio more particularly described as follows:

Beginning at an existing PK nail on the south line of VMS 12279 and the centerline of Hardin County T.R. 47, thence the following courses;

1. S.67°-47'-23"W. on the south line of VMS 12279, 2442.98' to a set #5 rebar at the southwest corner of VMS 12279, and passing over a set #5 rebar at 25.50' and crossing the Hardin-Logan County line at 972.43';
2. N.5°-34'-08"W. with the east lines of the Martha L. Williams 100 acre tract (O.R. 881, Page 416) and the Douglas Lee Maier et ux 108 acre tract (D.V. 406, page 956, Tract II), 1626.47' to an existing #5 rebar, passing over an existing cut stone monument at 694.10' on the Hardin-Logan County line;
3. S.83°-01'-13"W., 690.44' to a set #5 rebar;
4. N.12°-24'-19"E., 1742.78' to a set #5 rebar;
5. N.83°-01'-13"E., 1841.85' to a set Mag nail on the centerline of T.R. 47, passing over a set #5 rebar at 1816.85';
6. S.10°-27'-42"E. on the centerline of T.R. 47, 229.36' to a set Mag nail at the intersection with the centerline of vacated T.R. 208;
7. S.10°-31'-21"E. on the centerline of T.R. 47, 929.81' to an existing PK nail;
8. S.79°-28'-39"W., 229.26' to an existing #5 rebar, passing over an existing #5 rebar at 25.00';
9. S.10°-31'-21"E., 190.00' to a set #5 rebar;
10. N.79°-28'-39"E., 229.26' to an existing PK nail on the centerline of T.R. 47, passing over an existing #5 rebar at 204.26';
11. S.10°-31'-21"E. on the centerline of T.R. 47, 315.44' to an existing #5 rebar;
12. S.33°-36'-19"E., on the centerline of T.R. 47, 404.96' to an existing PK nail;
13. S.56°-23'-41"W., 155.60' to an existing #5 rebar, passing over an existing #5 rebar at 25.00';
