

Stanford Survey Rushcreek Township (Big Springs) Sept. 1964

Three Tracts.

The following described land in Rushcreek Township, Logan County, Ohio and being in V.M.S. 9956

Tract # 1 (South of Road Number 265) 0.88 Acre

Beginning at an iron in the center of State Route Number 274 and in the center of County Road Number 265. Thence with the center of County Road Number 265 S. $69^{\circ} - 00'$ E. 280.50 feet to an iron.

Thence S. $40^{\circ} - 20'$ W. 186.00 feet to an iron.

Thence with the north side of William Givens 0.49 acre tract N. $51^{\circ} - 49'$ W. 265.40 feet to an iron in the center of State Route Number 274.

Thence with the center of State Riute Number 274 N. $40^{\circ} - 43'$ E. 103.00 feet to the place of beginning. Tract # 1 contains 0.88 of one acre.

Tract # 2 (North of and adjacent to County Road Number 265)
1.05 acres.

Beginning at an iron in the center of State Route Number 274 qnd in the center of County Road Number 265. Thence with the center of State Route Number 274 N. $30^{\circ} - 25'$ E. 164.30 feet to an iron.

Thence S. $69^{\circ} - 58'$ E. 299.00 feet to an iron.

Thence S. $42^{\circ} - 50'$ W. 180.00 feet to an iron in the center of County Road Number 265.

Thence with the center of County Road Number 265 N. $69^{\circ} - 00'$ W. 259.00 feet to the place of beginning. Tract # 2 contains 1.05 acres.

Tract # 3 (North tract)

Beginning an an iron in the center of State Route Number 274 and in the center of County Road Number 265. Thence with the center of State Route Number 274 N. $30^{\circ} - 25'$ E. 164.30 feet to an iron. said iron being the true beginning point of this survey.

Thence again with the center of State Route Number 274 N. $30^{\circ} - 25'$ E. 86.50 feet to an iron.

Thence with the south side of Pearl Royer's 0.20 acre tract S. $64^{\circ} - 46'$ E. 136.00 feet to a two inch pipe.

Thence with the south side of Pearl Royer's 0.39 acre tract S. $88^{\circ} - 46'$ E. 227.00 feet to a square concrete post at the Rail Road right of way said post being fifty feet from the center line of the west tract. 3722

Thence S. 44° - 51' W. 160.00 feet to an iron,

Thence N. 69° - 58' W. 299.00 feet to the place of beginning.
