



Commencing at a 5/8" iron pin found for the intersection of centerlines of County Road 40 and State Route 274.





DESCRIPTION

Being a part of Virginia Military Survey No. 9956, Rushcreek Township, Logan County, Ohio and described as follows:

Bginning at an iron pin in the centerline of County Road 40 a distance of two hundred seventy two and six tenths feet (272.60') S 83°28'W from an iron pin at the intersection of the centerlines of said County Road 40 and State Route 274, said iron pin also being the northwest corner of a one acre tract referred to as J. Helfenstein's; thence continuing S 83°28'W along the said centerline a distance of one hundred sixty two and nine tenths feet (162.90') to an iron pin at the hortheast corner of a 67.44 acres tract known as J. Helfenstein's tract; thence S 6°45'E along the west line of said tract a distance of two hundred eleven feet (2110') to an iron pin; thence N 83°28'E a distance of two hundred eighteen and twenty six hundredths feet (218.26') to an iron pin; thence N 21°27'W a distance of two hundred eighteen and sixteen hundredths feet to the place of beginning containing in all nine hundred twenty three thousandths acres (0.923 acs.) of land but subject to all legal highways.
