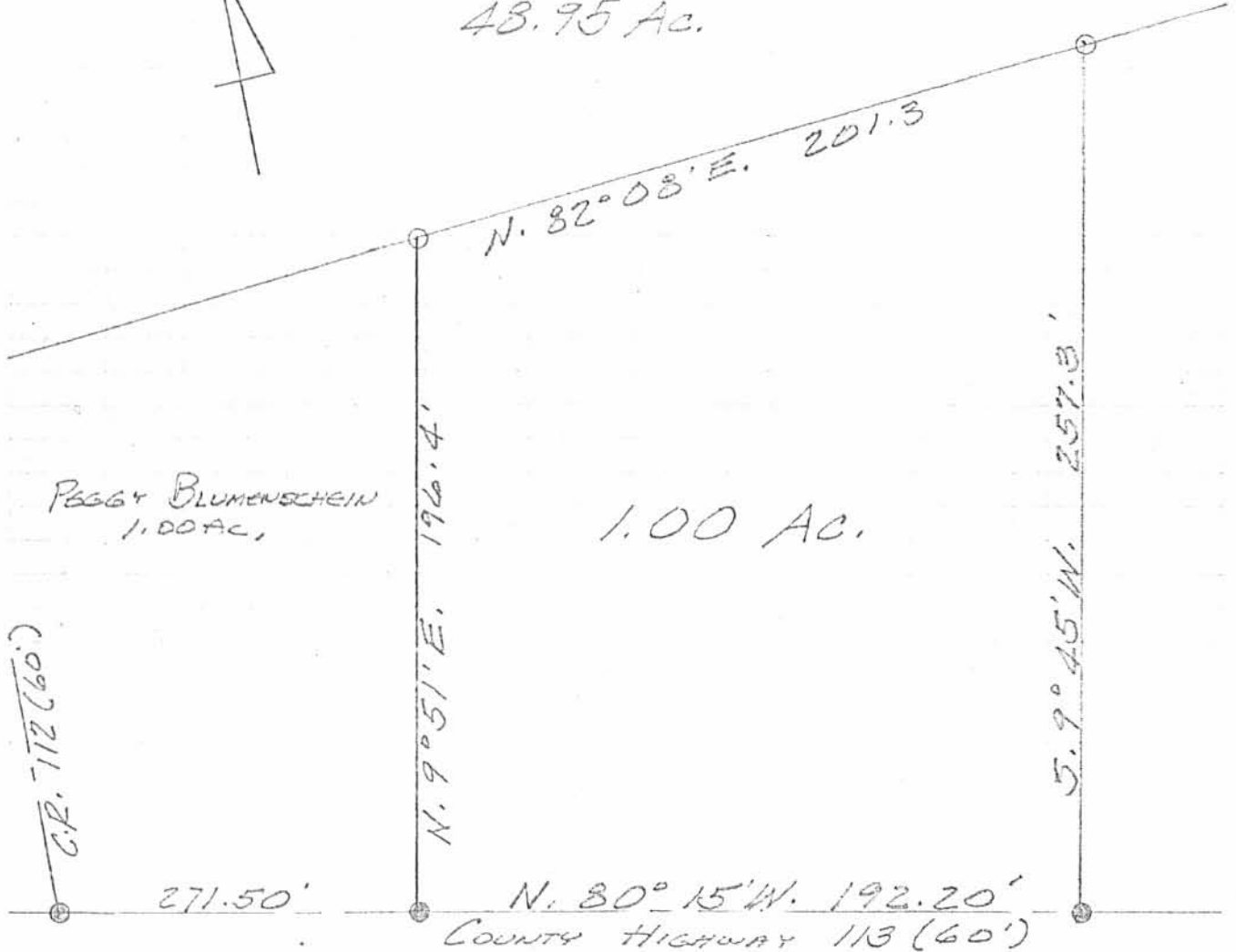

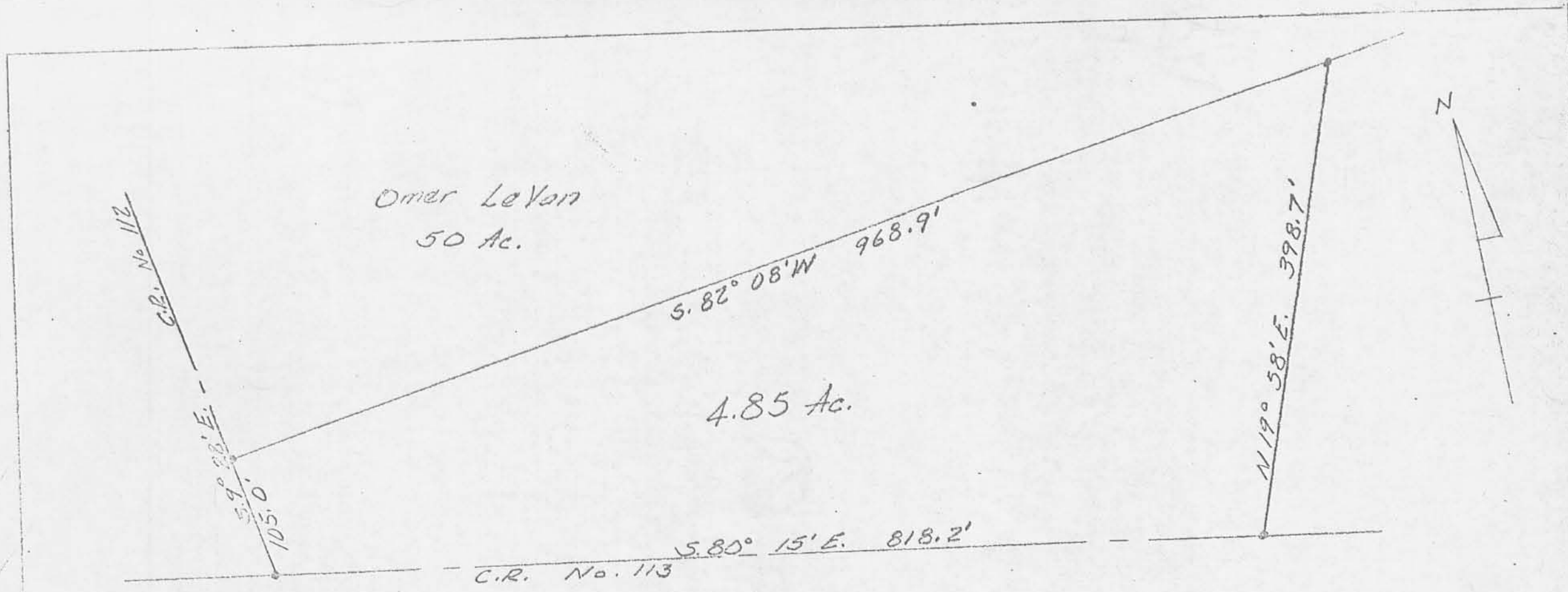
The following described real estate, situated in V.M.S. 13446, Rushcreek Township, Logan County, Ohio and being more particularly described as follows:
