


Being a parcel of land situated in Virginia Military Survey # 9977, Rushcreek Township, Logan County, Ohio and being a part of Parcel # 40-025-00-00-011, 56.81 acres as recorded, Robert E Wingfield land as described in OR. Vol. 111, Pg. 445 of the Logan County Deed records more particularly described as follows:

Beginning at a PK nail set in the centerline of County Road 40, this point being N. 83°-33'-45" E., 2353.92 feet from a 1/2" steel peg found at the intersection of the centerlines of County Road 40 and State Route 274;

- (1) Thence from this point of beginning N. 06°-16'-00" W., for 256.20 feet to a 1/2" iron pin set, passing at 30.00 feet a 1/2" iron pin set-
- (2) Thence N. 83<sup>o</sup>-28'-00" E., for 170.02 feet to a 5/8" iron pin found at the northwest corner of a 0.50 acre tract owned by Gerry Madison, DB. V.335 P. 796, parcel # 40-025-00-00-010-
- (3) Thence S. 06<sup>o</sup>-16'-00" E., along the west line of said 0.50 acre tract, for 256.20 feet to a 1/2" steel peg found in the centerline of C-40, passing at 226.20 feet a 5/8" iron pin found-
  - (4) Thence S. 83°-28'-00" W., along said centerline, for 170.02 feet to the point of beginning.

Containing in all 1.000 acres of land, 0.117 acres lying within the road right of way, leaving 55.81 acres by subtraction in parcel # 40-025-00-00-011, subject however to all legal easements and rights of way.
