FREY SURVEY

July 31, 1990

The following described real estate situated in the State of Ohio, County of Logan, Township of Rushcreek, being in Virginia Military Survey 9936 and more particularly described as follows:

Beginning at a p. k. nail set in the centerline of County Highway 50 that is S. 57° 00' 00" W. 1073.18 feet from a 3/4 inch iron bar found at the intersection of said centerline with the east line of V. M. S. 9936, (also the centerline of Township road 116).

Thence with said centerline S. 57° 00' 00" W. 200.00 feet to a p. k. nail set.

Thence N. 33° 00' 00" W. 230.00 feet to a 5/8 inch iron bar set, passing a 5/8 inch iron bar set at 30.00 feet.

Thence N. 57° 00' 00" E. 200.00 feet to a 5/8 inch iron bar set.

Thence S. 33° 00' 00" E. 230.00 feet to the place of beginning, passing a 5/8 inch iron bar set at 200.00 feet.

Containing 1.056 acres more or less, with 0.138 acre being in the right-of-way of County Road 50, leaving 0.918 acre.

The above described 1.056 acre tract being on the south side of Mary Wanda Frey's e.t.a.l. 48.94 acre tract as described in O. R. Vol. 87 Page 309.

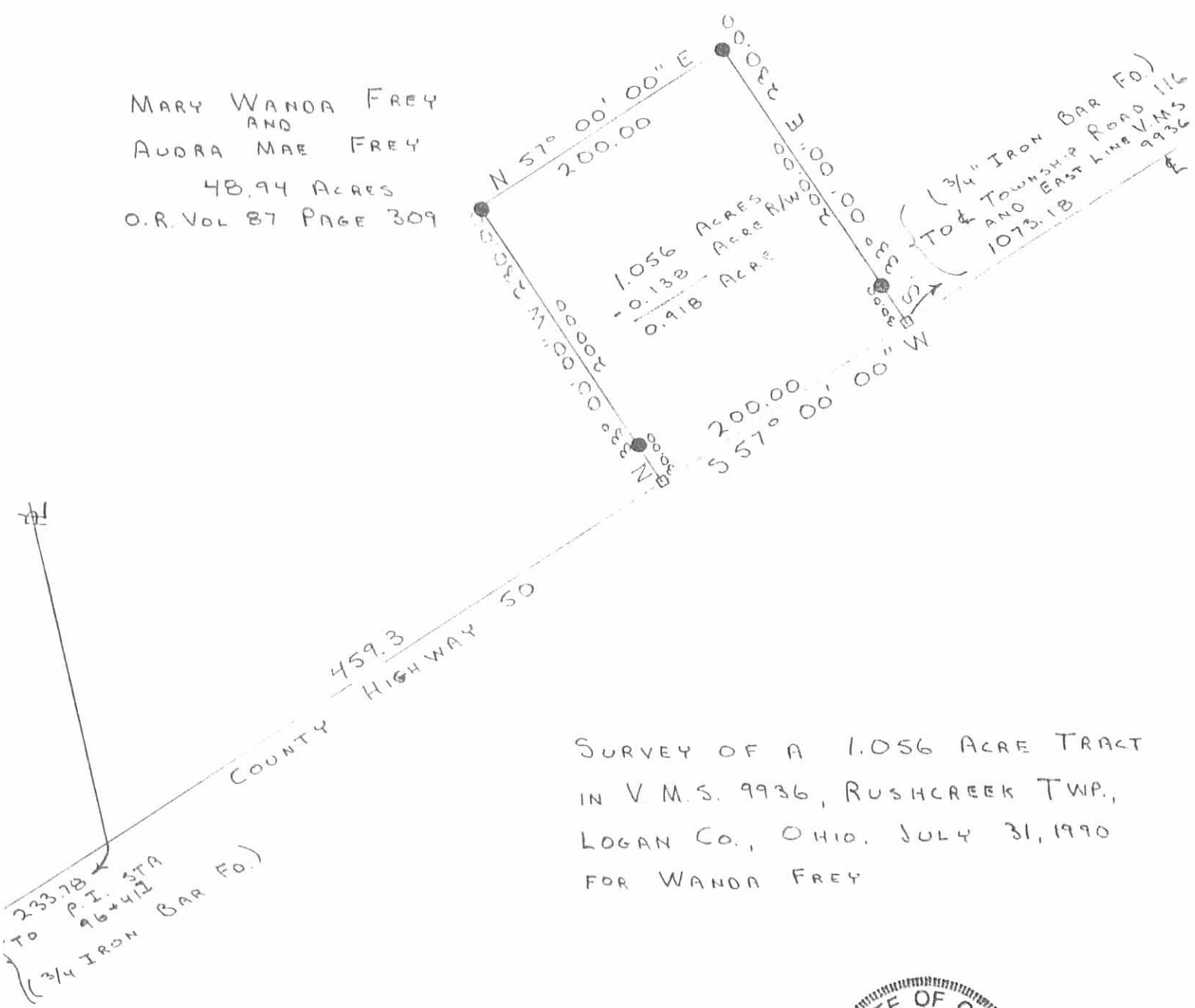
