LEGAL DESCRIPTION FOR PREDMORE'S 6.445 ACRE TRACT

Being situate in the State of Ohio, County of Logan, Township of Rushcreek, and being a part of Virginia Military Survey 10041, and being more particularly described as follows:

BEGINNING at a stone monument found at the intersection of the centerline of Township Road 110 (50' right-of-way) and the North line of Virginia Military Survey 10014, also being the South line of Virginia Military Survey 9955 and being at the Southwest corner of a 31.087 acre tract conveyed to Gary L. and Rosalie Kennedy, Trustees, by Deed recorded in Official Record 1190, Page 168, Tract 2, of the Logan County Records;

thence with the North line of V.M.S. 10041, the South line of said Kennedy's tract and with the South line of a 19.23 acre tract conveyed to Mark A Robinson by Deed recorded in Official Record 492, Page 393, N-78°08′24″-E, 933.75′(feet) to a 5/8″ diameter iron bar found on the centerline of State Route 274 (60′ right-of-way), passing for reference an iron bar set at 20.00′, the right-of-way line of Township Road 110 at 25.00′(feet), a Railroad Tie post at 649.10′(feet), and an iron bar set on the right-of-way line of State Route 274 at 887.89′(feet);

thence with the centerline of State Route 274, S-37°16'47"-W, 242.30'(feet) to an iron bar found;

thence continuing with the centerline of State Route 274, S-4°18′13″-E, 23.23′(feet) to a Mag Nail set on the North line of the CONRAIL Railroad;

thence with the North line of the CONRAIL Railroad the following three (3) courses:

- 1. S-51°23'39"-W, 36.32'(feet) to an iron bar set on the right-of-way line of State Route 274;
- 2. With the right-of-way line of State Route 274, N-4°18′13″-W, 18.16′(feet) to an iron bar set;
- 3. S-51°23′39″-W, 808.49′(feet) to a Mag Nail set on the centerline of aforementioned Township Road 110; passing for reference an iron bar set on the right-of-way line of Township Road 110 at 780.37′(feet);

thence with the centerline of Township Road 110, N-11°22′35″-W, 543.76′(feet) to the place of beginning.


Containing 6.445 acres, 0.494 acre of which is within the Roads rights-oF-ways, but being subject to the rights of all legal highways and all easements of record.


