LEGAL DESCRIPTION FOR SMITH'S 2,702 ACRE TRACT

Being situate in the State of Ohio, County of Logan, Township of Rushcreek, and being a part of Virginia Military Survey 9936, and being more particularly described as follows:

Beginning for reference at a ¾" diameter iron bar with monument cover found at the intersection of the centerlines of County Road 50 (60' right-of-way) and County Road 12 (48' right-of-way);

thence with the centerline of County Road 12, N-6°18′54″-W, 1227.38′(feet) to a Mag Nail set at the **PRINCIPLE PLACE OF BEGINNING** for the tract hereinafter described;

thence continuing with the centerline of County Road 12, N-6°18'54"-W, 343.00'(feet) to a Mag Nail set;

thence N-81°10′24″-E, 343.81′(feet) to an iron bar set, passing for reference an iron bar set on the right-of-way line of County Road 12 at 24.02′(feet);

thence S-9°36'37"-E, 275.42'(feet) to an iron bar set;

thence S-49°40'30"-W, 105.79'(feet) to an iron bar set;

thence S-68°15'10"-W, 70.36'(feet) to an iron bar set;

thence S-82°13′15″-W, 203.87′(feet) to the place of beginning, passing for reference an iron bar set on the right-of-way line of County Road 12 at 179.86′(feet).

Containing 2.702 acres, 0.189 acre of which is within the Road right-of-way, but being subject to the rights of all legal highways and all easements of record.


