Beginning at a magnetic nail set in the centerline of Sandusky Street that is N. 56° 55' 09" W. 35.00 feet from a 5/8 inch iron bar set at the northwest corner of Lot 211 of D. D. & A. M. Fawcett's Addition as shown on Slide 175 Cabinet A.

Thence with said centerline N. 33° 47' 00" E. 75.00 feet to a magnetic nail set.

Thence with the south line of Dorothy M. Strawser et al's 0.320 acre tract as described in O. R. Vol. 746 Page 921 (Parcel II Tract I) projected and said 0.320 acre tract S. 56° 55' 09" E. 186.27 feet to a 5/8 inch iron bar set, passing a 5/8 inch iron bar set at the southwest corner of said Tr. I at 35.00 feet.





Beginning at a 5/8 inch iron bar set in the east line of Sandusky Street at the southwest corner of Harold Mobley Jr. et al's 0.18 acre tract as described in O. R. Vol. 184 Page 418.

Thence with said Mobley's south line S. $55^{\circ} 43' 15''$ E. 150.00 feet to a 5/8 inch iron bar set in the west line of the Gilbert C. Myers' 0.18 acre tract as described in O. R. Vol. 610 Page 261, Tract II (this line is also referred to as the west line of a undedicated 16 foot alley), passing the remains of a 6 inch concrete post found at 144.39 feet.

Thence with said west line S. $33^{\circ} 36' 40''$ W. 24.53 feet to a 5/8 inch iron bar set.

Thence with the south line of said 0.18 acre tract and the south line of Gilbert C. Myers' 0.21 acre tract (tract I) as described in O. R. Vol. 610 Page 261 S. $55^{\circ} 57' 17''$ E. 191.60 feet to a point in the centerline of the ConRail Railroad, passing a 5/8 inch iron bar set in the west line of ConRail's right of way at 141.41 feet.






