Description of 0.003 Acre Building Easement

Dated September 20, 2022 for Richard Tiffany

Being part of Lot No. 726 in Nichelsons First Addition (Plat Cab. A, Slide 227) to the Village of Russells Point, now or formerly owned Richard A. & Pamela J. Tiffany, Official Record 1407, page 5995, and being PN 52-032-13-04-011-000, Washington Township, Logan County, State of Ohio and being more particularly described as follows:

Commencing at a point located at the intersection of the centerline of Marshall Street (30') with the centerline of Center Avenue (30'), said point referenced South 89 deg. 03 min. 09 sec. East a distance of 489.78 feet from a 1 inch dia. iron pipe found located at the intersection of the centerline of Marshall Street with the centerline of Lake Avenue;

Thence along the centerline of Center Avenue North 0 deg. 40 min. 40 sec. East for a distance of 214.66 feet to a point;

Thence North 89 deg. 03 min. 59 sec. West for a distance of 15.00 feet to an iron pin set, said point being the northeast corner of Lot 726;

Thence along the common line between Lot 726 & 727 North 89 deg. 03 min. 59 sec. West for a distance of 25.34 feet to a point, said point being the northeast corner of hereinafter described 0.003 acre easement and the true point of beginning;

Thence crossing Lot 726 the following courses and distances:

South 2 deg. 07 min. 38 sec West for a distance of 4.80 feet to a point;

North 87 deg. 53 min. 57 sec. West for a distance of 27.80 feet to a point;

North 2 deg. 07 min. 38 sec. East for a distance of 4.24 feet to a point located on the common line between Lot 726 & 727, said point referenced North 89 deg. 03 min. 59 sec. West for a distance of 26.84 feet to an iron pin set located at the northwest corner of Lot 726;

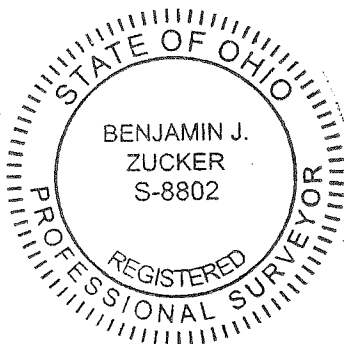
Thence along said lot line **South 89 deg. 03 min. 59 sec. East for a distance of 27.80 feet to a point, said point being the true place of beginning.**

Containing **0.003 acres**, (125 sq. ft) more or less, and subject to legal highways, easements, restrictions and agreements of record. 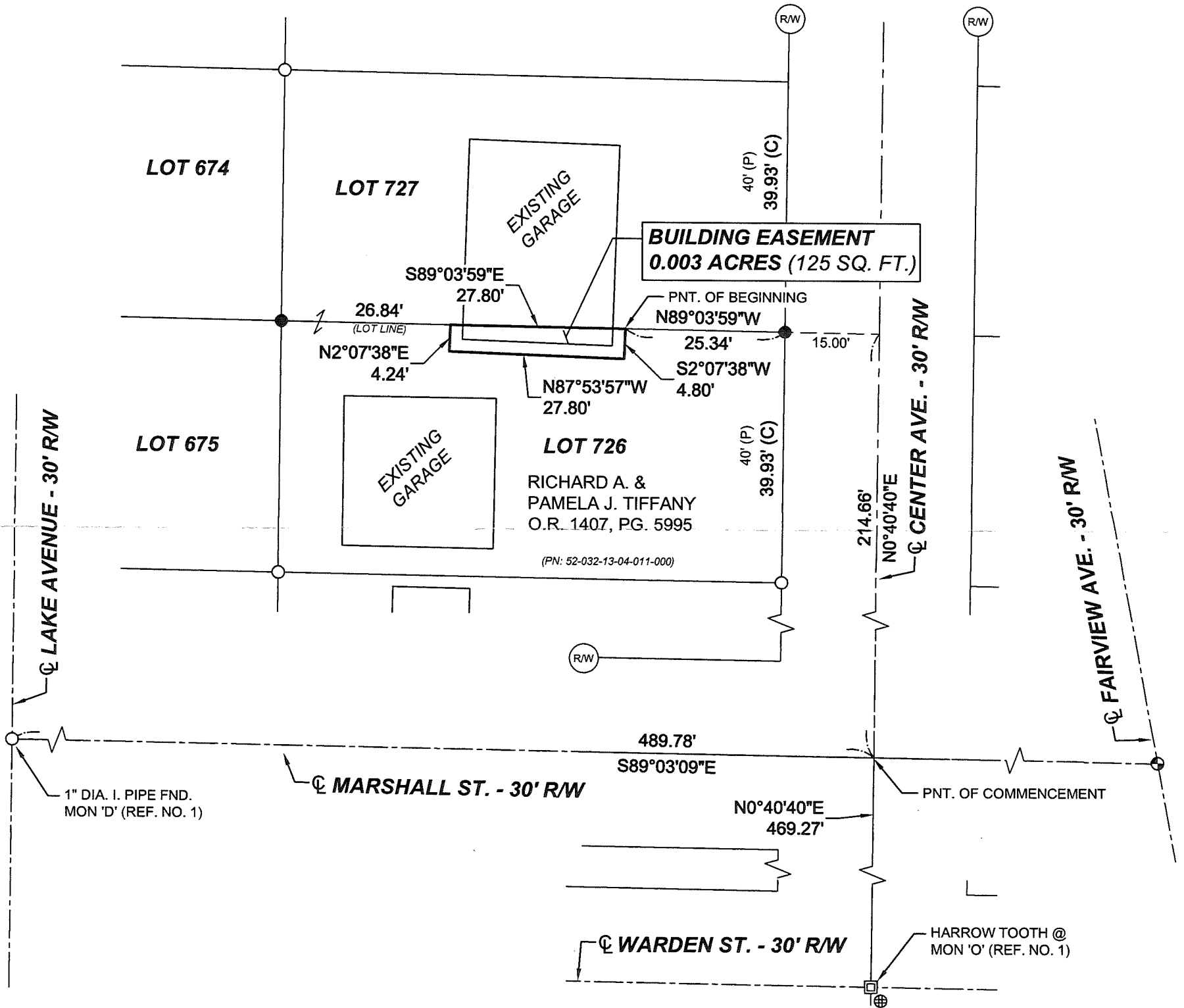
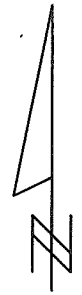

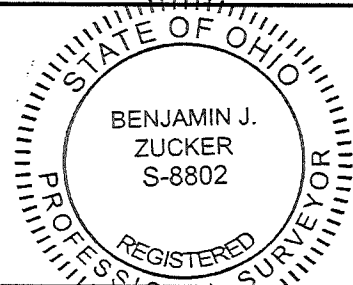
