DAVIS SURVEY

THENCE, with the said east line of Grand Avenue, N 0°-30' E, a distance of 3.00 feet to an iron rod.

THENCE, S 89°-20'-30" E, a distance of 80.00 feet to an iron rod set on the east line of said Lot 605.

THENCE, with said east lot line, S 0°-30' W, a distance of 2.50 feet to the southeast corner of said Lot 605.

THENCE, with the south line of Lot 605, N 89°-28' W, a distance of 80.00 feet to the point of beginning. Containing 220 square feet. (0.005 acre).

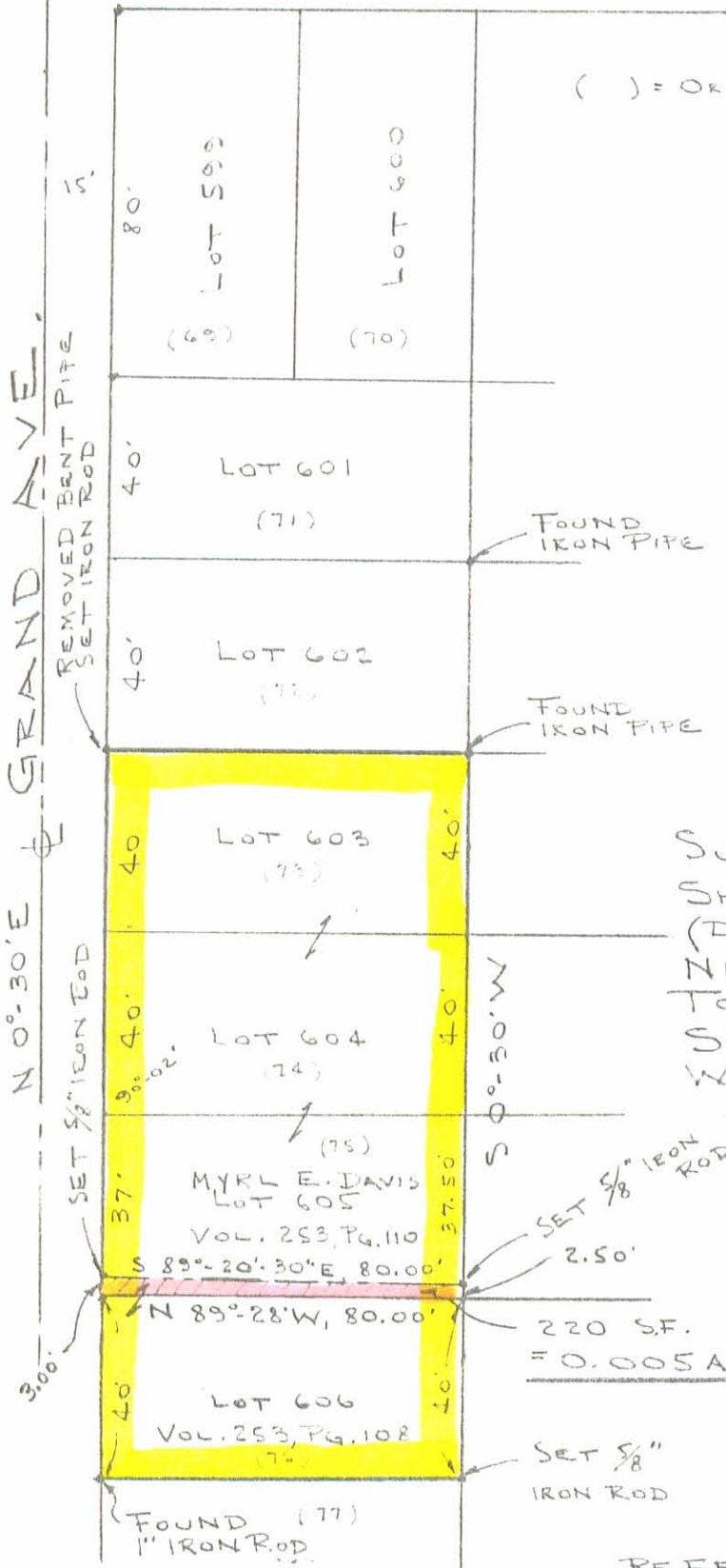
