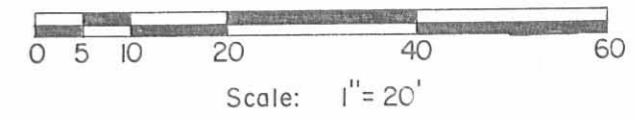
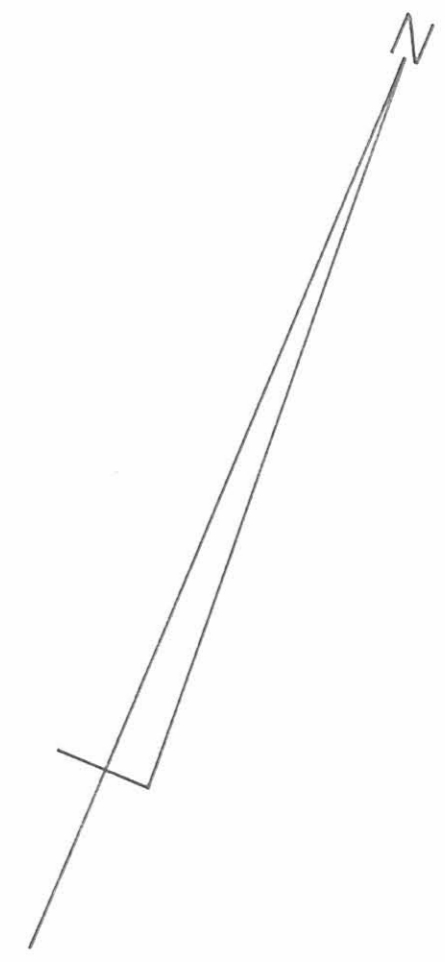

MEIER SURVEY

November, 1986

The following described real estate situated in the State of Ohio, County of Logan, Township of Washington, being part of Lot 124 of Cain Park in the Village of Russells Point and more particularly described as follows:

Beginning at a 0.625 inch iron bar in the north line of Lot 24 that is S. 66° 29' 56" E. 66.54 feet from an iron bar at the northwest corner of Lot 24. The above bearing is based on Ohio State Co-ordinates and all other bearings are from angles and distances measured in this field survey.

Thence with said north line S. 66° 29' 56" E. 28.62 feet to a 0.625 Inch iron bar at the northeast corner of said lot 124.

Thence with the east line of said Lot S. 23° 39' 34" W. 50.00 feet to a 0.625 inch iron bar in the north line of Cain Street.

Thence with said north line N. 66° 29' 56" W. 28.56 feet to a 0.625 inch iron bar.

Thence N. 23° 34' 58 " W. 50.00 feet to the place of beginning. Containing 1430 Sq. Ft. or 0.033 acre more or less.

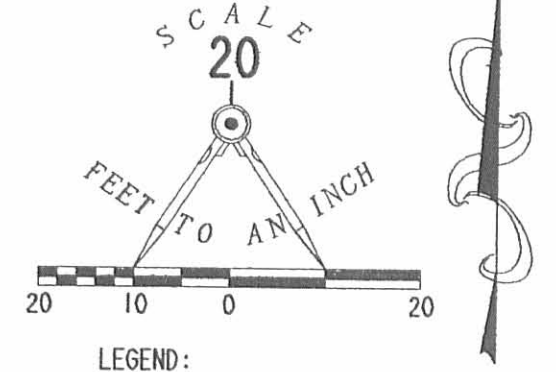
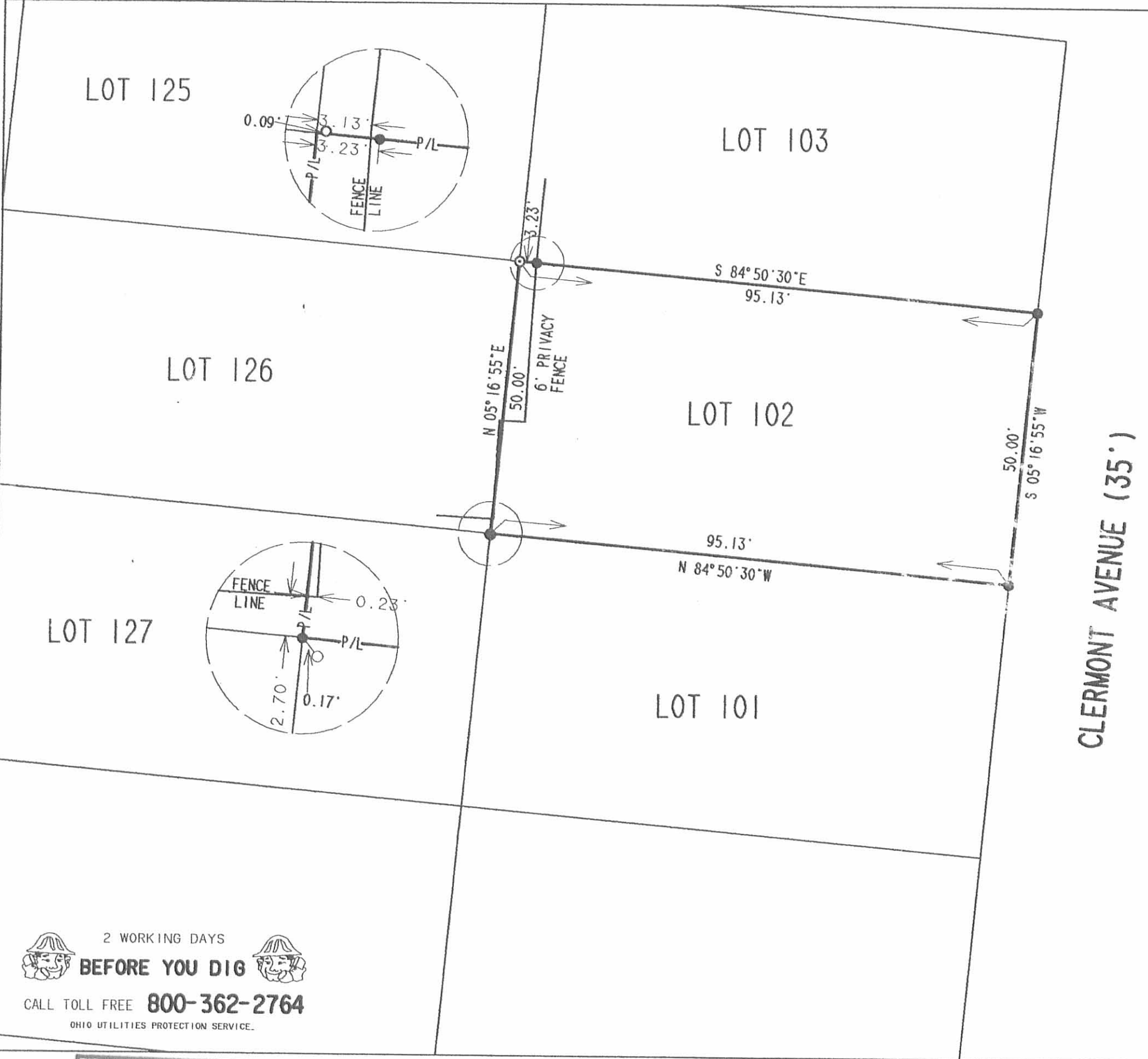
SURVEY OF 1430 S.F. TRACT ON
