Lying in Section 36, Town 6, Range 8, Village of Russells Point, Washington Township, Logan County, Ohio.

Being part of Lots 66, 93 (formerly Lots 47, and 52), and part of a vacated alley within the Village of Russells Point as dedicated in Cain's Allotment and recorded in Plat Cabinet A, Slide 152 of the Logan County Records of Plats. The said alley was vacated per Russells Point Ordinance 201 and described in Volume 225, Page 476 of the Logan County Records of Deeds. The tract being transferred is more particularly described as follows:

Beginning at a 5/8 inch iron rod set at the intersection of the northerly right-of-way of East Main Street (40 feet wide) and the west right-of-way of Warren Street (35 feet wide). The said 5/8 inch iron rod is, also, at the southeast corner of Lot 64.

THENCE, with the west right-of-way of Warren Street, N 23°-40'-14" E, a distance of 96.69 feet to a 5/8 inch iron rod found at the northeast corner of the Susan Kay Hodge 0.025 acre tract (O.R. 4, Pg. 159) and the TRUE POINT OF BEGINNING.

THENCE, with the northerly line of the said 0.025 acre tract, N 57°-28'-09" W, a distance of 51.35 feet to a chiseled 'X' found in concrete at the northwest corner of the said 0.025 acre tract.

THENCE, N 47°-29'-46" W, a distance of 10.77 feet to the northeast corner of a masonry building.

THENCE, with the northerly wall line of a masonry building, N 54°-48'-07" W, a distance of 37.38 feet to a 5/8 inch iron rod set.

THENCE, through Lot 93, N 28°-37'-17" E, a distance of 34.20 feet to a 5/8 inch iron rod set at the northwest corner of Lot 66.

THENCE, with the north line of Lot 66, S 66°-30'-49" E, a distance of 94.60 feet to a 5/8 inch iron rod set at the northeast corner of Lot 66.

THENCE, with the west right-of-way of Warren Street, S 23°-40'-14" W, a distance of 53.23 feet to the point of beginning.

Containing 0.098 acre of which there is the following breakdown:

0.021 acre in the vacated alley

0.076 acre in Lot 66

27.69 square feet in Lot 93

1.935 square feet in Lot 65

5.72 square feet in Lot 64



Lying in Section 36, Town 6, Range 8, Village of Russells Point, Washington Township, Logan County, Ohio.

Being part of Lots 93, 94, all of Lot 95 (formerly Lots 52, 50, and 51), and part of a vacated alley within the Village of Russells Point as dedicated in Cain's Allotment and recorded in Plat Cabinet A, Slide 152 of the Logan County Records of Plats. The said alley was vacated per Russells Point Ordinance 201 and described in Volume 225, Page 476 of the Logan County Records of Deeds. The tract being transferred is more particularly described as follows:

Beginning at a masonry nail set in concrete at the intersection of the northerly right-of-way of East Main Street (40 feet wide) and the east right-of-way of Clermont Street (35 feet wide). The said masonry nail is, also, at the southwest corner of Lot 95.

THENCE, with the easterly right-of-way of Clermont Street and the west line of Lot 95, N 23°-34'-28" E, a distance of 154.20 feet to a 5/8 inch iron rod set at the northwest corner of Lot 93 and the southwest corner of Lot 92.

THENCE, with the northerly line of Lot 93, S 66°-33'-41" E, a distance of 94.62 feet to a 5/8 inch iron rod set at the northeast corner of Lot 93.

THENCE, with the easterly line of Lot 93, S 23°-37'-26" W, a distance of 43.98 feet to a 5/8 inch iron rod set at the southwest corner of Lot 67.

THENCE, through Lot 93 and the vacated alley, S 28°-37'-17" W, a distance of 34.20 feet to a 5/8 inch iron rod set.

THENCE, through Lot 94, S 21°-50'-49" W, a distance of 96.09 feet to a 5/8 inch iron rod set at the southeast corner of Lot 94.

THENCE, with the north right-of-way of East Main Street, N 54°-40'-00" W, a distance of 96.49 feet to the point of beginning.

Containing 0.352 acre of which there is the following breakdown:

0.021 acre in the vacated alley

0.129 acre in Lot 93

0.100 acre in Lot 94

0.102 acre in Lot 95



Being part of Lots 64, 65, 94, (formerly Lots 48, 49, and 50), and part of a vacated alley within the Village of Russells Point as dedicated in Cain's Allotment and recorded in Plat Cabinet A, Slide 152 of the Logan County Records of Plats. The said alley was vacated per Russells Point Ordinance 201 and described in Volume 225, Page 476 of the Logan County Records of Deeds. The tract being transferred is more particularly described as follows:

Beginning at a 5/8 inch iron rod set at the intersection of the northerly right-of-way of East Main Street (40 feet wide) and the west right-of-way of Warren Street (35 feet wide). The said 5/8 inch iron rod is, also, at the southeast corner of Lot 64.

THENCE, with the northerly right-of-way of East Main Street and the southerly line of Lots 64 and 65, N 54°-40'-00" W, a distance of 96.49 feet to a 5/8 inch iron rod set at the southwest corner of Lot 65 and the southeast corner of Lot 94.

THENCE, through Lot 94, N 21°-50'-49" E, a distance of 96.09 feet to a 5/8 inch iron rod set.

THENCE, with the northerly line of a masonry building, S 54° -48'-07" E, a distance of 37.38 feet to the northeast corner of the masonry building.

THENCE, S 47°-29'-46" E, a distance of 10.77 feet to a chiseled 'X' found in concrete.

THENCE, with the lines of the Susan Kay Hodge 0.025 acre tract (O.R. 4, Pg. 159) the following two courses:

S 32°-16'-08" W, a distance of 20.46 feet to a 5/8 inch iron rod found.

S 57°-26'-29" E, a distance of 54.45 feet to a 5/8 inch iron rod found.

THENCE, with the west right-of-way of Warren Street, S 23°-40'-14" W, a distance of 75.96 feet to the point of beginning.

Containing 0.185 acre of which there is the following breakdown:

0.001 acre in the vacated alley

0.003 acre in Lot 94

0.100 acre in Lot 65

0.081 acre in Lot 64


