


Beginning at a ¾ inch iron pipe found at the northeast corner of Lot 400 of said Avondale Park Allotment and in the west line of Lake Drive (40 feet wide), said iron pipe also in the south line of said 0.047 acre tract;

Thence South 6°00'00" East 34.00 feet, following the east line of Lot 400 and the west line of Lake Drive, to an iron bar set;


Thence North 80°55'36" West 222.30 feet, departing from the west line of Lake Drive, crossing Lot 400 and Lot 46-334 of said Reservoir Lands, entering Lot 46-335 of said Reservoir Lands, passing an iron bar set for reference at 202.30 feet, to a point on the concrete retaining wall and in the east line of an existing channel to Indian Lake;

Thence North 12°47'38" East 3.68 feet, following the concrete retaining wall and the east line of said channel, to a point at the northwest corner of Lot 46-335 of said Reservoir Lands;

Thence South 78°30'06" East 10.14 feet, departing from the east line of said channel and following the north line of Lot 46-335 of said Reservoir Lands, to a point at the southwest corner of Lot 46-334 of said Reservoir Lands;

Thence North 5°52'09" East 38.40 feet, departing from the north line of Lot 46-335 of said Reservoir Lands and following the west line of Lot 46-334 of said Reservoir Lands, crossing a boat slip, following the concrete retaining wall and the east line of said channel thereafter, to a point at the southwest corner of Lot 46-333 of said Reservoir Lands, said point also at the westernmost corner of said 0.013 acre tract and at the southwest corner of Dean Arras, Trustee's 0.053 acre, Parcel 1, described in Official Record Volume 718, page 253;

Thence South 84°30'09" East 220.50 feet, departing from the east line of said channel, following the north line of said 0.013 acre tract, the north line of said 0.047 acre



tract, the south line of said 0.053 acre tract, and the south line of Dean Arras, Trustee's 0.415 acre, Parcel 2, described in Official Record Volume 718, page 253, passing 5/8 inch iron bars found at 10.32 feet, at 105.08 feet, and at 199.96 feet, to a railroad spike found in the centerline of Lake Drive;

Thence South 6°00'00" East 24.25 feet, following the centerline of Lake Drive and the east line of said 0.047 acre tract, to a railroad spike found;

Thence North 78°29'00" West 21.16 feet, departing from the centerline of Lake Drive and following the south line of said 0.047 acre tract, to the place of beginning, containing 0.238 acre, more or less, and subject to all valid easements and restrictions of record.
