
JOHNSON SURVEY SEMINOLE SHORES SUBDIVISION 2 STOKES TOWNSHIP October 2, 1962

TRACT 4

The following described real estate situated in Stokes Township, Logan County, Ohio and being part of Virginia Military Survey 12276 and more particularly described as follows:

Beginning at an iron bar at the southwest corner of lot 116 of Seminole Shores Subdivision No. 2 as shown on Logan County Recorders Plat Book C, Volume 3, page 34; thence with the south line of lots 116, 115 and 114, 243.45 feet to an iron bar at the southeast corner of lot 114, said iron bar also being in the west line of Scioto Drive; thence with the west line of Scioto Drive extended, S. 23° 33' W. 389.5 feet to the point of curve of a curve to the right having a central angle of 92° 27' and a radius of 20.0 feet thence with said curve southwesterly to the point of tangency of said curve and in the north line of Iroquois Drive extended; thence with said north line, N. 64° 00' W. 200.0 feet to the point of curve of a curve to the right having a central angle of 87° 33' and a radius of 20.0 feet; thence with said curve northerly to the point of tangency of said curve and in the east line of Hiawatha Drive extended; thence with said east line 338.52 feet INDEXED ON MAP to the place of beginning.

Containing 2.11 acres more or less.

SURVEY FOR TJL LAKESIDE 2.106 Acres July 23, 2020

The following described 2.106 acre tract is situated in the State of Ohio, County of Logan, Township of Stokes, and V.M.S. 12276, being all TJL Lakeside, LLC's 2.11 acre tract described in Official Record 1349, page 482, and said 2.106 acre tract being more particularly described as follows:

Beginning at an iron pin set in the east line of Hiawatha Drive (50 feet wide), at the northwest corner of said 2.11 acre tract, and at the southwest corner of Joel A. and Julie A. Phillips' Lot 116 and Lot 115 described in Official Record 1352, page 407, said iron pin marking the southwest corner of Lot 116 of Seminole Shores Subdivision No. 2 as shown in Plat Cabinet A, on slide 253, and marking the *place of beginning*;

Thence *South 78°03'20" East (assumed bearing) 243.36 feet*, following the north line of said 2.11 acre tract and the south line of said Lot 116 and Lot 115, passing at 153.36 feet a ¾ inch square iron bar found at the southwest corner of Brandon L. and Brandi J. Hartzell's Lot 113 and Lot 114 described in Official Record 1303, page 917, thereafter following the south line of said Hartzell's Lot 114 to a ¾ inch square iron bar found at the southwest end of Scioto Drive (50 feet wide) and at the northwest corner of Seminole Island Civic Association's 0.4591 acre tract described in Official Record 79, page 232;

Thence **South 21°57'22"** West 388.92 feet, following the east line of said 2.11 acre tract and the west line of said 0.4591 acre tract, to an iron pin set;

Thence following a southeast line of said 2.11 acre tract and the northwest line of said 0.4591 acre tract on a curve to the right, said curve having a chord bearing South 68°11'24" West, a chord length of 28.89 feet, a curve length of 32.28 feet, a tangent of 20.88 feet. a delta of 92°28'03", and a radius of 20.00 feet, to an iron pin set in the north line of Seminole Island Civic Association's 0.6657 acre tract described in Official Record 79, page 232;

Thence *North 65°34'35" West 199.93 feet*, following the south line of said 2.11 acre tract and a north line of said 0.6657 acre tract, to an iron pin set;

Thence following a southwest line of said 2.11 acre tract and a northeast line of said 0.6657 acre tract on a curve to the right, said curve having a chord bearing North 21°48'09" West, a chord length of 27.67 feet, a curve length of 30.56 feet, a tangent of 19.16 feet, a delta of 87°32'52", and a radius of 20.00 feet, to an iron pin set in the east line of Hiawatha Drive;

Thence *North 21°58'17" East 338.00 feet*, following a west line of said 2.11 acre tract and the east line of Hiawatha Drive, to the *place of beginning*, *containing 2.106 acres*, more or less, and being subject to all valid easements and restrictions of record.

The above described 2.106 acre tract has access to unimproved Hiawatha Drive as dedicated in Seminole Shores Subdivision No. 1 as shown in Plat Cabinet A on slide 251.

The above description was prepared from a field survey made under the supervision of Paul R. Clapsaddle, Registered Surveyor 6140, during the month of July 2020. Bearings indicated herein are based on an assumed meridian with all others based on angles turned. Iron pins set are 5/8 inch by 30 inch reinforcing rods with caps marked "CLAPSADDLE RS 6140".
