WHEREAS on the 24th day of January, 1974, Mr. William R. Dickson, Jr., and fourteen other freeholders filed a petition to vacate the following portion of Stokes Township Road No. 52 as hereinafter described:

Being part of Stokes Township Road No. 52 situated in Sec. 35, Town 6 south, Range 8 east and Sec. 2, Town 7 south, Range 8 east, Stokes Township, Logan County, Ohio.

Commencing at State Route No. 235; thence easterly approximately 0.5 mile to the Houchin Slough Ditch and there terminate.

WHEREAS the Board of Logan County Commissioners viewed the said premises on February 15, 1974 at 11:00 A.M., and

WHEREAS the road has the appearance of not being used as a public way for over 21 years, and

WHEREAS on March 1, 1974 at 10:00 A.M., a hearing was scheduled in the Office of County Commissioners and no opposition was voiced in person or in writing,

THEREFORE BE IT RESOLVED that the Logan County Commissioners grant the prayer of the petition and that the foregoing described portion of road be vacated with the suggestion that Mr. William Dickson, Jr., give an easement of right-of-way to Mr. Homer Myers.

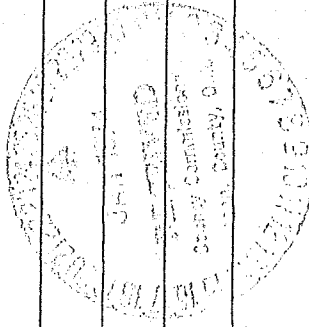
