Lying in Section 15, Town 6, Range 8, Stokes Township, Logan County, Ohio.

Being out of the remaining lands of Richard S. Taylor original 80 acre tract as deeded and described in Vol. 339, Pg. 101 of the Logan County Records of Deeds and being more particularly described as follows:

Beginning at a P.K. nail found on the center-line of State Route 366 and at the tangent to spiral station 12+11.64 of the Ohio Department of Transportation survey of State Route 366.

THENCE, with a 200 foot spiral to the right having a curve radius of 2291.83 feet, an intersection angle of 20°-18'-48", and a degree of curvature of 2°-30'-00" on a chord bearing of N 88°-00'-00" E, a distance of 42.52 feet to a P.K. nail found at a point on the spiral, THE TRUE POINT OF BEGINNING.

THENCE, with said spiral to the right and center-line of State Route 366 having a chord bearing of N 88°-55'-05" E, a distance of 157.48 feet to a P.K. nail set at the spiral to curve center-line station 14+11.64.

THENCE, with the center-line of State Route 366 on a simple curve to the right having a curve radius of 2291.83 feet, an intersection angle of 20°-18'-48", an arc length of 199.58 feet, and a chord bearing of S 86°-55'-08" E, a distance of 199.52 feet to a P.K. nail set on the center-line of State Route 366 at station 16+11.22.

THENCE, S 0°-16'-26" W, a distance of 269.64 feet to a 5/8 inch iron rod set, passing a 5/8 inch iron rod set at a distance of 45.20 feet.

THENCE, N 89°-43'-35" W, a distance of 355.98 feet to a 5/8 inch iron rod set.

THENCE, N 0°-07'-10" E, a distance of 275.72 feet to the place of beginning, passing a 5/8 inch iron rod set at 234.14 feet.

Containing 2.257 acres of which 0.363 acre is within the road right-of-way.

The basis for bearing is based upon the center-line tangent of State Route 366 being N 88°-00'-00" E, and all other bearings are from angles and distances measured in a field survey performed by Lee Surveying and Mapping Company on February 11, 1991.

Being out of the remaining lands of Richard S. Taylor original 80 acre tract as deeded and described in Vol. 339, Pg. 101 of the Logan County Records of Deeds and being more particularly described as follows:

Beginning at a bolt found on the north/south quarter section line of Section 15, Town 6, Range 8 and on the center-line of State Route 366 at station 18+85.61.

THENCE, with the said quarter section line, S 0°-07'-57" W, a distance of 228.02 feet to a 5/8 inch iron rod set, passing a 5/8 inch iron found at a distance of 44.75 feet and a 5/8 inch iron rod found at a distance of 208.02 feet.

THENCE, N 89°-43'-35" W, a distance of 271.61 feet to a 5/8 inch iron rod set.

THENCE, N 0°-16'-26" E, a distance of 269.64 feet to a P.K. nail set on the center-line of State Route 366 at station 16+11.22, passing a 5/8 inch iron rod set at 224.44 feet.

THENCE, with the center-line of State Route 366 and on a curve to the right, having an intersection angle of 6°-51'-35", a radius of 2291.83 feet, an arc length of 274.39 feet, the chord of which bears S 80°-59'-34" E,a distance of 274.23 feet to the place of beginning.

Containing 1.550 acres of which 0.280 acre is within the road right-of-way.

The basis for bearing is based upon the center-line tangent of State Route 366 at P.I. Station 17+22.34 (back) as being N 88°-00'-00" E, and all other bearings are from angles and distances measured in a field survey performed by Lee Surveying and Mapping Company on February 11, 1991.



Beginning at a 'PK' nail found on the east line of said 80 acres and being on the center-line of State Route 366, marking the southeast corner of the A. Schmidthorst 16.351 acre tract.

THENCE, with the east line of said 63.649 acres, along the east line of the said SW quarter of Section 15, S 0°-07'-10" W, a distance of 228.42 feet to a tacked hub, passing an iron rod set for reference at 208.42 feet.

THENCE, N 89° -44'-20" W, a distance of 627.54 feet to a tacked hub, passing an iron rod set for reference at 20 feet to the right at 477.54 feet.

THENCE, parallel to the east line, N 0°-07'-10" E, a distance of 275.72 feet to a 'PK' nail set on the center-line of State Route 366 at highway Station 12+54.16.

THENCE, with said highway, easterly with a spiral chord, N 89°-00' E, a distance of 157.48 feet to a 'FK' nail. (Concrete monuments found 40 feet north and south). This point being the S.C. of said highway curve at Station 14+11.64.

THENCE, with the simple curve of said center-line, having a radius of 2291.88 feet, the chord bearing S 83°-34'-40" E, a distance of 472.94 feet to the point of beginning. Containing 3.742 acres. Leaving for transfer 59.907 acres.
