

S. 33, passing an iron pin at 1,017.42 feet; thence N. 06° 41° 00" E. along said centerline of U. SURVEYOR'S DESCRIPTION

thence N.11° 23'34"W. along the centerline of the Van Horn Creek, a distance of 76.24 feet to a point;

thence N.01° 01'36"W. along the centerline of the Van Horn Creek, a distance of 121.11 feet to a point in the North line of the Northeast Quarter of Section 22, Stokes Township, said point was the true PLACE OF BEGINNING.
