Thence South 23° 17' 00" West, a distance of 37.56 feet, along the westerly line of said Township Road 293 and the easterly line of said 0.050 acre tract, to the **Point of Beginning**, containing 0.044 acres, more or less and being subject to all easements, restrictions and rights-of-way of record.




