LEGAL DESCRIPTION FOR MICHAEL S. JONES, SR., 0.120 ACRE TRACT

Being situate in the State of Ohio, County of Logan, Township of Stokes, and being a part of Virginia Military Survey 12277, and being more particularly described as follows:

Beginning for reference at a 5/8" diameter iron bar with "Geeslin" cap found projecting 1.0' above grade at the Southeast corner of Lot 1 of the Newland Allotment as recorded in Plat Cabinet "A", Slide 387 of the Logan County Plat Records, said iron bar found also being on the West line of East Drive which is a 20' wide Private Drive;

thence with the West line of said East Drive, S-29°54'11"-W, 42.01'(feet) to a 5/8" diameter iron bar found 0.2' below grade at the intersection of the West line of said East Drive and the South line of Newland Drive of which is a 50' wide Private Drive;

thence with the South line of said Newland Drive, S-78°12'31"-E, 118.85'(feet) to a railroad spike set at the PRINCIPLE PLACE OF BEGINNING for the tract hereinafter described, said railroad spike set being at the Northeast corner of a 0.878 acre, tract conveyed to Michael S. Jones, Sr., by Deed recorded in Official Record 294, Page 40 of the Logan County Records and also being at the Northwest corner of 0.419 Acre tract also conveyed to Michael S. Jones, Sr. by Deed recorded in Official Record 237, Page 764 of the Logan County Records;

thence continuing with the South line of Newland Drive, S-78°12'31"-E, 10.09'(feet) to an iron bar set;

thence S-6°27'29"-W, 134.36'(feet) to an iron bar set on the South line of said Jones' 0.419 acre tract, also being on the North line of a 0.060 acre tract conveyed to Thomas G. Burton by Deed recorded in Deed Volume 337, Page 508 of the Logan County Deed Records;

thence with the North line of said Burton's tract and with the North line of a 0.051 acre tract conveyed to Linda L. Bailey by Deed recorded in Official Record 383, Page 736 of the Logan County Records and with the North line of a 0.390 acre tract conveyed to Patricia M. Simpson by Deed recorded in Official Record 279, Page 889 of the Logan County Records, N-87°54'13"-W, 66.84'(feet) to an 5/8" diameter iron bar found at grade, at the Southeast corner of aforementioned Jones' 0.878 acre tract, passing for reference an 7/8" diameter iron pipe found projecting 0.7' above grade at the Northeast corner of aforementioned Bailey's 0.051 acre tract at 18.99'(feet);

thence with the East line of Jones' 0.878 acre tract, N-28°24'59"-E, 151.36'(feet) to the place of beginning;

Containing 0.120 acre, but being subject to the rights of all legal highways and all easements of record.

Being a part of the 0.419 acre tract conveyed to Michael S. Jones, Sr., by Deed recorded in Official Record 237, Page 764 of the Logan County Records.

The herein described tract is to be attached to an existing and adjoining parcel and is not to be used as a separate and independent tract.



Thence with said South line extended N. 77° 58' W. 12.19 feet to a point; said point being the beginning point of this description;


Thence continuing with the South line of said drive N. 77° 58' W. 132.03 feet to a 0.625 inch iron bar.






