VAN HORN TO STACHLER

Lying in the south east quarter of Section 22, T-6-S, R-8-E, Stokes Township, Logan County, Ohio.

Being out of that 35.924 acres lying in the name of Wilma K. Van Horn as deeded and described in Volume 349, Page 884 of the Logan County Records of Deeds and being more particularly described as follows:

Beginning at a railroad spike set on the center-line of Duff Road (Township Road 87). This also being the south line of Section 22 and being N 88°-43' E, along said section line, a distance of 625 feet from the southwest corner of the southeast quarter of Section 22 and marking the southeast corner of the Kenneth Stachler 0.416 acre lot (Volume 401, Page 473).

THENCE, with the east line of said 0.416 acre lot, N 1°-20' W, a distance of 145.00 feet to an iron rod marking the northeast corner of said 0.416 acre lot.

THENCE, with the north line of said 0.416 acre lot extended easterly, N 88°-43' E, a distance of 67.42 feet to an iron rod.

THENCE, parallel to and 50.00 feet westerly from the grantor's east line, S 1°-20' E, a distance of 145.00 feet to a railroad spike set on the center-line of said Township Road 87.

THENCE, with said center-line of Township Road 87, S 88°-43' W, a distance of 67.42 feet to the point of beginning.

Containing 0.224 acre.
