Thence **North 34°29′25″ East 34.89 feet**, following the easterly line of Lot 3 of said KIA-WAH WOODS SUBDIVISION No. 1 and the westerly line of Lot 6 of said KIA-WAH WOODS SUBDIVISION No. 2, to a 5/8 inch iron bar found at the westernmost corner of Dwight E. Reed and Jane C. Reed, Trustees' Lot 7 of KIA-WAH WOODS SUBDIVISION No. 2 and described in Official Record Volume 1115, page 673;

Thence **South 44°33′50″ East 80.90 feet**, following the southwesterly line of Lot 7 of said KIA-WAH WOODS SUBDIVISION No. 2 and the northeasterly line of Lot 6 of said KIA-WAH WOODS SUBDIVISION No. 2, to an iron bar set;

Thence **South 59°17'23" West 48.09 feet**, departing from the southwesterly line of Lot 7 of said KIA-WAH WOODS SUBDIVISION No. 2 and crossing Lot 6 of said KIA-WAH WOODS SUBDIVISION No. 2, to the **place of beginning, containing 0.067 acres** more or less and subject to all valid easements and restrictions of record.

The 0.067 acre tract of land described herein is to be attached to an adjoining parcel and may not be used as a separate or independent tract.




