THENCE, with the south line of Section 19 and the center-line of Township Road 45 (40 feet wide), S 84°-00'-00" E, a distance of 1683.58 feet to a railroad spike set at the TRUE POINT OF BEGINNING.

THENCE, parallel to and approximately 25.0 feet east of the west line of the said 54.04 acre tract, N 5°-57'-54" E, a distance of 275.28 feet to a 5/8 inch iron rod set, passing a 5/8 inch iron rod set at 20.00 feet.

THENCE, with the south line of Section 19 and the center-line of Township Road 45, N 84°-00'-00" W, a distance of 191.00 feet to the point of beginning.

Containing 1.208 acres, of which 0.088 acre is within the highway right-of-way.



thence with the South line of Baker's tract, S-83°54'34"-E, 771.98'(feet) to an iron bar set;

thence S-5°04′16″-W, 2716.73′(feet) to a Mag Nail set on the centerline of aforementioned Township Road 45, passing for reference an iron bar set on the right-of-way line of Township Road 45 at 2696.73′(feet);

thence with the centerline of Township Road 45 and the South line of Section 19, N-84°27'49"-W, 771.88'(feet) to a Mag Nail found on the Quarter Section line;

thence continuing with the centerline of Township Road 45 and the South line of Section 19, N-84°53′18″-W, 545.92′(feet) to a 1″diameter iron pipe found at the Southeast corner of a 0.960 acre tract conveyed to Mark A. & Patricia J. Osborne by deed recorded in Official Record 468, Page 489;

thence N-4°11′42″-E, 240.00′(feet) to a 1″ diameter iron pipe found at the Northeast corner of Osborne's tract, passing for reference an iron bar set on the right-of-way line of Township Road 45 at 20.00′(feet);

thence with the North line of Osborne's tract, N-84°53'18"-W, 175.00'(feet) to a 1" diameter iron pipe found on the East line of a 1.208 acre tract conveyed to Jay R. & Sadie M. Strayer by deed recorded in Official Record 678, Page 845;

thence with the bounds of Strayer's tract the following three (3) courses:

- 1. N-4°11'42"-E, 41.25'(feet) to a 5/8" diameter iron bar found;
- 2. N-86°42'32"-W, 186.79'(feet) to a 5/8" diameter iron bar found;

Containing 104.400 acres, 0.616 acre of which is within the Road right-of-way, but being subject to the rights of all legal highways and all easements of record.
