BAZZLE-WILLIAMS SURVEY

Lying in the southwest quarter of Section 2, T-3, R-14, Union Township, Logan County, Ohio.

Being the southwest corner of that 17.41 acres (18.41 original) as deeded and described in Volume 400, Page 713 of the Logan County Records of Deeds. Being more particularly described as follows:

Beginning at a 1" square iron bar found marking the inter-section of the center-lines of County Road No. 18 and County Road No. 43.

THENCE, with the old center-line of County Road 18 (Property line), N 27°-45' E, a distance of 523.31 feet to a 1" square iron bar found at an angle in said line. Designated as being Station 5+23.31 in the County Survey Records (F.B. 702, Page 54-63).

THENCE, continuing with said property line and old center-line, N 56°-41'-17" E, a distance of 19.74 feet to an iron rod.

THENCE, S 19°-38'-35" E, a distance of 555.05 feet to a point in Twin Lake on the south line of Section 2, passing an iron rod set at 92.85 feet.

THENCE, with said section line and south property line, N 83°-46' W, a distance of 449.40 feet to the point of beginning, passing an iron rod near the edge of the lake at 23 feet.




