Thence with the north line of said Kauffman's tract and the quarter section line, S. 84° 28'00" E. 341.75 feet to a 5/8" x 30" Rebar set;

Thence S. $4^{\circ}59'00"$ W. 894.00 feet to a 5/8" x 30" Rebar set; Thence S. 84°03'00" E. 254.75 feet to a 5/8" x 30" Rebar set;
